Registration for admission will start from 20.07.2026 9:00 am to 25.07.2026 1:00 pm (through Offline mode). Registration form can be received from Vidyalaya at free of cost.

Duly filled registration form along with all required documents can be submitted in Vidyalaya up to 25.07.2026 (1:00 pm) only.

Admission is subject to following conditions:

- The child has been in the same course of studies i.e. in a CBSE affiliated school.
- For Class X, the child must have obtained not less than 55% marks in aggregate in class IX.
- For admission to class XII, 55% marks in class XI examination is mandatory.
- The child should otherwise be eligible as per KVS Admission Guidelines.
- The combinations of subjects opted by the student are available in the Vidyalaya.

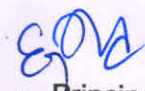
f) Fresh Admission will be for Priority category I to III in this vidyalaya

Subject: Filling up of Vacant Seats from Balvatika to Class XII in Kendriya Vidyalayas - reg.

Madam/Sir,

It is observed that a number of seats from Balvatika to Class XII are still lying vacant in various Kendriya Vidyalayas under different Regions. As per the provisions contained in **PART-A, Para 10 (Admission for Vacant Seats)** of the KVS Admission Guidelines 2026-27, after 30th June, the Deputy Commissioner of the Region is empowered to allow admissions up to the prescribed class strength i.e. 40, as per the prescribed priorities in admission, up to 31st July of the concerned Academic Year.

In view of the above and with a view to ensuring optimum utilisation of the available infrastructure and educational resources while providing maximum opportunities to eligible children, you are requested to personally monitor the admission process in the Kendriya Vidyalayas under your jurisdiction and take all necessary steps to fill the vacant seats up to the prescribed class strength by **31st July 2026** in accordance with the provisions of the KVS Admission Guidelines 2026-27. you are requested to ensure that the concerned Kendriya Vidyalayas give adequate publicity regarding the availability of vacant seats through appropriate local channels such as the Vidyalaya website, notice board and other suitable modes so that eligible candidates are informed in time.

The action taken in this regard may be monitored closely to ensure that no seat remains vacant where admissions can be granted under the provisions of the Admission Guidelines. For each vacancy, despite best efforts to fill the seat, the school administration should have adequate justification.
