FOR THE SESSION – 2026-2027

- 1) Admission will be granted only on production of all the original relevant documents at the time of admission and their verification.
- 2) Information provided by the parents, if found incorrect at the time of verification of documents for admission, the offer of admission will be cancelled and the seat will go to the next candidates in the waiting list.
- 3) Parents who will not report to Vidyalaya about their admission confirmation & document verification in given time, admission will be cancelled and seat will be allotted to the wait listed children in next list.
- 3) Self attested Xerox / original copies of the following documents are required to be submitted with printed application form:-
 - i) Birth Certificate. (Self attested Xerox copy)
 - ii) **Residential certificate (Any One):- LPG Receipt/Electricity Bill/Voter ID/Bank Passbook or other Govt. issued valid documents (Other than Adhaar)**
 - iii) Transfer order for the employee of CAT-1 (Self Attested Xerox copy)
 - iv) Identity Card(Copy) and Service Certificate(Original in KVS Proforma) from Cat I, II, III &IV
 - v) Certificate for SC/ST/OBC-NCL/BPL/EWS candidate. (Self Attested copy)
 - vi) Physically handicapped certificate if applicable. (Self Attested copy)
 - vii) **OBC-NCL Certificate of within 1-year of Father or Child (issued by Govt. of India Central List of OBC-NCL)**
 - viii) 1- Photo of child and Blood Group Child. If not available then undertaking.
 - ix) Discharge certificate for Ex-servicemen. (Self Attested Xerox copy)
 - x) Self declaration regarding distance between the residence and school (in Prescribed Proforma) in case of RTE along with **Google Map Printout.**
 - xi) Copy of Online Application form along with the acknowledgement generated by Computer at the time of registration.
 - xii) Certificate showing no. of transfer undergone.
