
Name and Designation of the Officer In-charge.

Anantapur District located in Rayalaseema Region of Andhra Pradesh is the Drought Prone and most backward area of the Country. Anantapur town has a Population of about THREE LAKHS. There are several Central Government Offices, Organizations such as Railways, Post & Telegraphs, Telecommunication, AIR, TV. Central Excise, Intelligence etc.; Under Autonomous Organizations there are Three Universities Viz. Sri Krishnadevaraya University, a branch of Jawaharlal Nehru Technological University, a branch of Andhra Pradesh Agricultural University ; There are also Corporations like Food Corporation of India etc.
