

- The rent payable by the Lessee to the lessor shall be Rs.1/= per annum (Rupee one only) for the site of Fifteen acres.
- The lessee must construct the building at his cost and within a period of four years from the date of delivery of the site by the lessor.
- 3. The rent shall be paid from the date of handing over of site of to the lessee.
- 4. Construction plan & work to be executed as per K.V.S.norms
- 5. The buildings must not be used for any purpose other than Location of Kendriya Vidyalaya and Kendriya Vidyalaya Staff Quarters and other allied matters pertaining to academic activities of K.V.S.
- 6. The Building shall not be assigned or sub-let.
- 7. The lessee must pay charges to the lessor for rendering any special services required in maintenance of K.V.S. Buildings externally, such as sewage, electricity, water etc., or be requisitioned by the lessee for getting the job done through the lessor.
