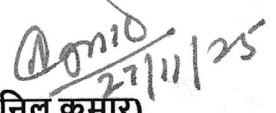

**RECRUITMENT OF VARIOUS TEACHING & NON-TEACHING POSTS IN KENDRIYA
VIDYALAYA SANGATHAN AND NAVODAYA VIDYALAYA SAMITI**

PUBLIC NOTICE

It reference to Notification 01/2025, the online application submission for recruitment to various teaching and non-teaching posts in KVS and NVS has been started from 14th November 2025. The CBSE is regularly monitoring application submission portal and till date more than 11 lakh candidates have successfully submitted their application for different posts which shows that there is no technical issue in the portal. But still many candidates are sending emails/applications under RTI Act 2005/Grievances on portal as well as making phone calls to various phone numbers of KVS, NVS and CBSE mentioning technical issues in submission of application on the portal.

One major issue mentioned in these mails/applications under RTI Act 2005/ Grievances on portal as well as on phone calls is that **portal is not allowing them to proceed further due to not meeting essential qualification criteria for the selected post**. In this regard, the candidates are once again informed that the qualifications for many of the posts in KVS & NVS are not similar and there is slight difference in qualification even the post name may be same in both organisations. Due to this difference in qualification(s), there are multiple dropdown of qualifications shown in the portal against each post. The candidates, before applying for any of the post(s), are advised to read the Notification thoroughly & carefully and check whether their qualification(s) is/are exactly matching to the qualification(s) mentioned in the Notification. Accordingly, the candidates should choose the post and concerned qualification(s) on the application portal. If the candidates are choosing correct qualification(s) as is mentioned in Notification for the post which they are applying, their application would proceed further. But if they choose incorrect qualification, the portal will restrict them to proceed further.

Another issue mentioned in emails received from candidates is regarding **payment updation on the portal or refund of failed transactions**. In this regard, candidates are advised to read instruction at serial no. 16 on page 34 of the Notification where it is clearly mentioned that in case your transaction is not updated on the portal, you will have to pay fee again and amount of earlier transaction will automatically refunded to your bank account within a week's time.

Some candidates are asking for interpretations or relaxation in qualification(s) mentioned in the Notification. In this regard, the candidates are informed that qualification(s) mentioned in the notification are final and no variation or relaxation in qualification(s) is allowed.

If the Confirmation Page is not displayed after the payment, the transaction is considered incomplete, and the amount will be refunded to the candidate's account. In such cases, candidates will be required to initiate a new transaction to complete the payment process.
2	Portal is not allowing them to proceed further due to not meeting essential qualification criteria for the selected post	You might have selected incorrect qualification from drop-down. Since the qualification for some similar type of post(s) in KVS and NVS are not same, check your qualification with that mentioned in the Notification word by word (minutely) for the post you wish to apply. Do not interpret your qualification or the qualification mentioned in Notification, check it word by word. If your qualification is matched word by word with the qualification for a post in KVS, select the post in KVS in application portal and select the qualification shown in dropdown which matches with your qualification. If your qualification is matched word by word with the qualification for a post in NVS, select the post in NVS in application portal and select the qualification shown in dropdown which matches with your qualification. If your qualification is matched word by word with the qualification for a post in KVS and NVS, select the post in both KVS and NVS in application portal and select the qualification shown in dropdown which matches with your qualification.
