

The building structure is improvise it is well ventilated with adequate lighting and has portable water, wholesome water.


We have no objection for running the firm unit on sanitary grounds and advice the management to maintain sanitation at the premises and surroundings.

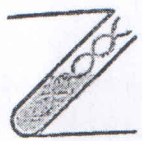
