1.	The total number of section of the school shall be restricted to 12 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 11 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

1	01 Library Conditions not satisfied .
2	02 school is required to appointment special editor counselor and wellness teacher.
3	03 The School must have approval for introduction of additional subjects (Science Stream) issued by the Competent Authority of the School for future inspection etc.
4	04 The School is required to maintain its own website and upload the Mandatory public Disclosure as per appendix-IX of affiliation Manual on its website.
5	05 The School is required to appoint trained & qualified teachers for teaching additional (Science) Subject as per norms.

6	06 The School is required to purchase subject specific books for the school Library as per norms.
7	07 The School is required to maintain well equipped Science Labs with all the Mandatory equipment's and room size as per specification mentioned in the Affiliation Bye-Laws-2018.
8	08 The School required to restricted student upto 32 student in each room as per class room size which is below 500 sq ft and further directed to construct classroom as per affiliation Bye-laws.
9	09 The School has directed to renew all the mandatory safety certificate from the state Govt. time to time
10	10 PGT Teacher to be appointed.
11	11 The School is required to inform the board about the shifting of school from temporary site to permanent site when the School will shift as per affiliation Bye-laws through SARAS Portal.
