## MINUTES

of

### VIDYALAYA MANAGEMENT COMMITTEE MEETING

held on 20/02/2026

A meeting of the Vidyalaya Management Committee of PM SHRI KV Pandhurna was held on 20.02.2026 at 2:30 p.m. under the chairmanship of **Mr. Neeraj Kumar Vashishth, District Collector Pandhurna** along with other members of VMC **Mr. Hansraj Meena**, the Principal of **PM SHRI KV Pandhurna**, extended a warm welcome to the Chairman, along with all the VMC members.

The following points were discussed in the meeting:

- VMC members were informed about the action taken on the discussed issues of the previous meeting which was held On December 18, 2025.
- Principal raised a very serious issue of shortage of various regular teachers, which affects the quality of teaching-learning process of the Vidyalaya. This issue was taken in the consideration to correspond with KVS Headquarter.
- Minute information about the upcoming interview for contractual teachers that is on 26.2.2026 has been provided to the Chairman. The Chairman has recommended two members for the interview panel.
- VMC members were given the status of the ongoing work of the construction of vocational lab in the vidyalaya under PM SHRI Scheme.
- Minute report on the second medical & health check up of students was presented in the meeting.
- A serious issue of drinking water crisis in the vidyalaya was also raised in the meeting, to which Chairman Sir gave the necessary instructions to the concerned department and asked the vidyalaya to correspond with higher authorities of KVS to arrange funds for pipelines to get water from filter plant.

- Chairman Sir suggested to make MP of the constituency aware about the water crisis in the vidyalaya and ask funds from Sansad Nidhi to solve the problem permanently by laying the pipeline from water filter plant to the vidyalaya.
- Chairman Sir gave the assurance for the underpass on national highway-47 so that students can cross the highway safely.
- Chairman Sir intimated that KV Sousar proposal of land acquisition has been prepared and sent to the concerned authority.
- Chairman Sir assured night police patrolling of KV Pandhurna campus and security measures for the students, attending sports camp, at MPL Ground.
- Chairman Sir appreciated the initiative of organizing remedial coaching camp during autumn and winter breaks for the betterment of the academic results.
