Qualifications acquired by the candidates should be strictly in accordance with the prescribed qualifications and candidates should not seek claim of equivalence of their qualifications with that of qualifications as asked for. Wherein grades have been given, equivalent marks of gradation should be attached.
5. Candidates should not fill in those qualifications in the application form for which they have appeared in any of the examination whose result is awaited/withheld/not declared/marks sheet not received till the last date of submission of applications.
