TERMS AND CONDITIONS / नियम और शर्तें:

5. If the successful bidder fails to pay the sale price, then the items shall be sold to the next higher bidder.
6. KVS employees and their relatives are not allowed to participate in the bid.
7. The auctioned goods have to be removed immediately; otherwise the school will not be responsible for any loss.
