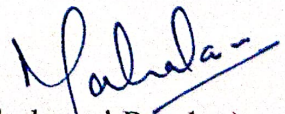


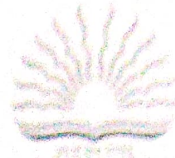

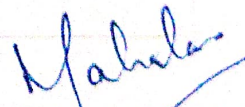
1. Formal welcome of the Ex-Officio Chairman and the Hon'ble Members of the Vidyalaya Management Committee.

1.	Constitution of the Vidyalaya Purchase Committee for the upcoming academic session 2026-27.	The Vidyalaya Purchase Committee was duly constituted for the Academic Session 2026-27 with the approval of the Hon'ble Chairman, VMC. The Committee is functioning as per KVS guidelines.
2.	Formation of the Physical Verification Committee for the session 2026-27.	The Physical Verification Committee was constituted with the approval of the Hon'ble Chairman, VMC, and the committee has undertaken its assigned responsibilities in accordance with the prescribed KVS norms.
3.	Constitution of the Vidyalaya Executive Committee (VEC) for the session 2026-27.	The Vidyalaya Executive Committee (VEC) was constituted with the approval of the Hon'ble Chairman, VMC, and is functioning effectively for the Academic Session 2026-27.
4.	Reconstitution of the Parent-Teacher Association (PTA) and its Executive Committee for a three-year tenure effective from 1st April 2026.	The Parent-Teacher Association (PTA) and its Executive Committee were reconstituted for a three-year tenure with effect from 1st April 2026 after obtaining the approval of the Hon'ble Chairman, VMC, in accordance with KVS guidelines.
5.	Procurement of Catering and Tentage services via GeM Portal for the Regional Sports Meet (Kho-Kho Girls U-14, 17) to be hosted by the Vidyalaya from 28th to 30th April 2026.	The procurement of Catering and Tentage Services for the Regional Sports Meet (Kho-Kho Girls U-14 & U-17), hosted by the Vidyalaya from 28th to 30th April 2026, was successfully completed through the GeM Portal with the approval of the Hon'ble Chairman, VMC.
6.	Approval for the exterior white-washing of the Vidyalaya building to be executed during the upcoming summer vacation as per budget allocation within ceiling. Purchase will be done through GeM Portal.	The proposal for exterior white-washing of the Vidyalaya building was approved by the Hon'ble Chairman, VMC. However, the work could not be executed during the summer vacation as proposed due to paucity of time and budget. The work is now proposed to be undertaken in the coming months during the current academic session from the approved funds received under the PM SHRI Scheme for this purpose, subject to completion of the requisite procurement process through the GeM Portal.
7.	Reconstitution of the Internal Complaint Committee (ICC) for a three-year tenure starting from the academic session 2026-27 onwards.	The Internal Complaints Committee (ICC) was reconstituted for a three-year tenure commencing from the Academic Session 2026-27 with the approval of the Hon'ble Chairman, VMC, as per the applicable guidelines.

Replacement of Teacher Member and parent members in VMC for the session 2026-27, as per KVS norms	The replacement of the Teacher Member and Parent Members in the Vidyalaya Management Committee was carried out with the approval of the Hon'ble Chairman, VMC, in accordance with the prevailing KVS norms.
9.	Discussion on Admission procedure and guidelines for the session 2026-27	Admission procedure for the session 2026-27 was executed as per the KVS guidelines and norms. As per the KVS guidelines the admission is closed as on 30-06-2026 for the session 2026-27.
