Madam/Sir,

With reference to the subject cited the following steps should be taken by the Principals to complete the admission process of Class XI by 28<sup>th</sup> May 2025 following the below mentioned steps and the given schedule:

- a) The KV should print the registration form as per the sample attached and distribute it to the students from 19<sup>th</sup> May 2025. Principals may modify the choice of the subject column as per the combination available in their KV.
- **b)** Registration forms should be distributed to the students of the same KV and to the students of the nearby KV where Class-X is the highest class.
- c) The last date for submitting the duly filled registration form is 23<sup>rd</sup> May 2025.
- d) Principals should prepare combined merit list-1 based on the aggregate (best five subjects including 02 language subjects) up to the strength of 50 and display in the notice board by 24<sup>th</sup> May 2025. Concessions wherever applicable as per the admission guidelines should be incorporated while preparing the merit list.
- e) Admission of the selected students of their own KV and nearby KV should be completed by 28<sup>th</sup> May 2025.
- f) Principals of the KV running up to Class-X and having nearby KVs with Class-XI may instruct the students/parents to collect the registration form from the nearby KV. Students may collect registration forms as per the following arrangements:
