- b) For Class X, the child must have obtained not less than 55% marks in aggregate in class IX. For admission to class XII, 55% marks in class XI examination is mandatory.
- c) The child should otherwise be eligible as per KVS Admission Guidelines.
- d) The combinations of subjects opted by the student are available in the concerned Kendriya Vidyalaya.
- e) Fresh Admission will be for Priority category I and II only.
