Important Instructions:-

- 1. Candidates reporting time is 8:00 AM.
- 2. Candidates should bring original and one set of self-attested copies ofcertificates, testimonials, photo identity and one passport size photo. Candidates will have to ensure the collection of their original documents just after the documents verification before leaving the desk of verification.
- 3. Proof of identity (POI) and other requisite documents along with passport size photographs must be carried out on the day of walk ininterview.
- 4. A self-attested copy of POI will be submitted along with each set of documents for the post or different posts, as the case maybe.
- 5. Kindly check your eligibility before applying. Bilingual proficiency (Hindi and English) is required for all the posts.
- 6. The following documents need to be submitted to the Document Verification Team:

a) Duly filled bio-data./Application form(Available in the vidyalaya website)

- b) Self-attested photocopies of eligibility documents.
- c) Self-attested photocopies of identity proof and address proof.
- d) A self-attested document containing your mobile number and emailID for communication.
- e) Self-attested photocopies of documents claiming experience in the post held for the post.
- f) One passport size color photograph for each post applied for.
- 7. Age Limit for all above posts: Minimum and maximum age limit shall be 18 and 65 years respectively as on 31st March, 2025.
- 8. No TA/DA will be paid for attending the interview.Terms and conditions are as per KVS norms. Knowledge of Computer is desirableforall posts.
- 9. This interview is only for preparing a panel of different posts to be engaged on purely part time contractual basis as and when required.
- 10. Complete details should be filled carefully in the Bio-Data/Application form. Paste a recent photograph and signature at the appropriate places as per instructions contained in the Bio-Data form.
- 11. Candidates are required to have a valid personal Email ID and Mobile number. Both Email id and Mobile should be kept active during thecurrency of this contractual appointment. In case a candidate does not have a valid personal Email ID, he/she should create his/ her new Email ID before applying.
- 12. At the time of filling the Bio-Data form, candidates are advised to fill their particular i.e.Name, Father's/Mother's Name, Date of Birth, Gender and other details correctly. After registration or at the time of interview, the request for change of particulars in the bio-data form will not be entertained by this KV.
- 13. Candidates are required to visit KV website: <u>https://chakradharpur.kvs.ac.in/</u>regularly with regard to view the updates regarding Interview.
- 14. Neither Information shall be entertained by this KV nor shall send a separate intimation to the candidates to this effect.
- 15. No fee is required to be paid by candidates for registration or interview.
- 16. A candidate may apply for more than one post if he /she is eligible and desires to do so. In such cases, the candidate will have to fill the Bio Data Form/Application form separately for all the posts applied for.A set of self-attested photocopies of all Certificates, Mark-sheets, Testimonials and id proof must be attached with each Registration-cum-Bio Data Form.
- 17. Candidates must carry the valid id proof on the day of Interview. ID proof includes PAN CARD/AADHAR CARD/PASSPORT/DRIVING LICENCE/VOTER ID CARD /ANY VALID PHOTO ID ISSUED BY GOVT.
- 18. Legal action may be taken for the falsification of the information.
- 19. After the due process of the interview, the panels of different posts will be prepared and uploaded on the website of the Vidyalaya. In lieu of need assessment of the Vidyalaya, listed candidates in the panel will be called upon as per rank assigned. In case of non-response or failure to report, the next in merit candidate will be called upon in the interest of the students. Services of the selected candidate in ranks

panel will be taken if it is found satisfactory after the class observation by the Principal/Vice Principal/Senior Most Teacher.

- 20. For contractual teachers/coaches etc., salary/honorarium will be payable as per the KVS rules applicable from time to time.
- 21. In the interest of the Vidyalaya if required, the Principal has the right to remove any contractual employee of the Vidyalaya with out assigning any reason.
- 22. Knowledge of computer is desirable for all posts.
- 23. Before availing the services of the selected candidate, a letter of consent for the benefit of KVS will be signed between the candidate and the Principal on non-judicial stamp paper of minimum Rs100.
- 24. If insufficient applications are received for any post then re-interview may be conducted or eligible and qualified contract teachers may also be selected from the panelof other KVs of Ranchi Region.
