Madam/Sir,

With reference to the letter no. and subject cited above, this is to inform that Kendriya Vidyalaya Sangathan has been conducting Learners' Achievement Tests (LAT) as a system-level academic intervention to assess students' learning attainment and readiness in alignment with the learning outcomes prescribed by NCERT.

The LAT-II, 2025-26 will be conducted as per the following schedule:

- Date: 30 January 2026
- Time: 9:00 am to 11:00 am for classes 3 and 5 and 9:00 am to 11:30 am for class 8 (for both shifts).

The following are the key-aspects of the test items included in the LAT papers:

The design of test items will be focusing on the following key aspects:


- **Assessment Items:** The test items will be derived from NCERT textbooks of the relevant and preceding grades and aligned with the prescribed learning outcomes. The items will be in the form of multiple-choice questions with a single correct response, designed to assess conceptual understanding and learning progression.
- **Curricular Alignment:** The assessment will focus on the essential competencies and concepts expected to be attained by learners up to the relevant grade level, ensuring coherence with curricular expectations.
- **Cognitive Skills:** The questions will aim to assess higher-order thinking skills, moving beyond rote learning to evaluate comprehension, application and analytical abilities.

Maintaining the confidentiality and integrity of the assessment process is of utmost importance. In this regard, Principals are requested to ensure compliance with the following guidelines:

- **Password-protected question papers:** Password-protected question papers will be shared in advance.
- **Timely Dissemination:** Schools will receive the question papers one day prior to the test date. Necessary arrangements should be done for printing, such as RISO, photocopiers, or printers, to accommodate the student strength in Classes 3, 5, and 8.
- **Evaluation and Data Entry:** Similar to LAT-1, schools will be required to enter students' responses in the Google Spreadsheets.
- **Overall Report Preparation:** Principals must ensure that the evaluation and data entry in the Google Worksheets must be complete in time for further necessary analysis and action.

The LAT-II is expected to provide valuable insights into students' learning levels and progress, thereby enabling timely and targeted academic interventions at the school level.
