1. Educational Qualification of PGT(Chemistry)

Essential:

- Integrated Post Graduate Course from NCTE **recognized** university In the concerned subject with at least 50% marks In aggregate Including B.Ed component.

OR

- Master Degree from a **recognized** University with at least 50% marks in aggregate in the following subject

Important note for the applicants:

4. Registration will be done from 8:00 AM – 09:00 AM on the day of interview only.
5. Applicants shall confirm their suitability for the post in terms of educational/professional qualification.
6. Appearing in interview does not confer the right to appointment on contractual basis. Part-time contractual engagement will be done in case any such vacancy arises or when teachers proceed on long leave.
Teachers engaged on contractual basis, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of Kendriya Vidyalaya.
7. Candidates having B.Ed (Special) are not eligible to apply for the post wherever B.Ed is required.
