विषय: Processing of Local Transfer 2025-26-reg

महोदया / महोदय.

It is decided to invite applications of Local Transfer for the year 2025-26. KVs of Ernakulam Region have been divided into clusters as per the list attached in Annexure A. Principals of concerned KV where the student is presently studying will issue prescribed proforma - Annexure B, for local transfer to the interested parents from 20.06.2025 onwards. After completing the application form (in duplicate) in all respect, the parent will submit it to the Principal of the KV where admission is sought by 30.06.2025.

KVs will then forward all the completed local transfer applications by speed post with all the required documents to this office, so as to reach this office by 05.07.2025. One copy of

the application should be kept at Vidyalaya.

Processing of local transfer applications will be done at Regional office, Ernakulam. Parents should be asked to provide supporting documents to prove their claims. Local transfer applications are to be recommended only if the average class strength is less than 45 for classes upto IV and less than 50 for classes V & above as on 30.06.2025. The following grounds may be considered while recommending the cases: -

1. In case of the allotment of Government Accommodation or shifting to own house to/by the parent (Priority category I to IV in Civil/Defence Sector KV and Priority Category I to V in

Project/IHL Sector KV) in previous/ current academic session.

2. Medical urgency/serious illness of the student / parent.

3. Sibling of the student is studying in the KV where admission is sought.( in such cases, the Deputy Commissioner of the Region will approve the Local Transfer in the either KV which has lesser class strength out of the KVs where siblings are studying).

Local Transfer application due to distance / proximity to house / lack of transport facility etc. will not be considered.

Please note the following points in this regard:

a. Fresh admissions done in this academic year, 2025-26 should not be forwarded.

b. Notice regarding Local Transfer 2025-26 should be displayed on the notice board and also on the Vidyalaya website.
