ORDERS:

Orders were issued in this office ref. cited allotting Ac.4.15 and 3.08 in S.No.914 of Andireddipalem in favour of Kendriya Vidyalaya and Industrial Dept. (for location of D.L.T.C. and I.T.I., Guntur) respectively with a clear indication to utilize the land only for the purpose for which it is sought for allotment and it should be utilized within six months failing which the land will be resumed to Revenue Department.

Even after a lapse of two years the Asst. Director, (Training) District Level Training Centre and Industrial Training Institute, Guntur has not utilised the land of Ac.3.08 allotted for location of Dist. Level Training Centre and I.T.I., Guntur so far.

Further the Director of Employment and Training, Hyderabad in his letter No.81/49087/79, dt.26-6-86 has reported that the land of Ac.3.08 allotted is not sufficient for the construction of Dist. Level Training Centre and I.T.I. Evidently the land is not required by them. Hence the allotment made in favour of Asst. Director of (Training) Dist. Level Training Centre and I.T.I., Guntur is hereby cancelled.

The Collector, Guntur and Customs and Central Excise and Chairman, Vidyalaya Management Committee, Kendriya Vidyalaya, Guntur has requested for allotment of additional extent of Ac.3.00 for construction of Central School. Hence the extent of Ac.3.08 in S.No.914 of Andireddipalem is hereby allotted to Kendriya Vidyalaya on payment of Market value to be fixed by the Government.
