- d) <u>Installation of CCTV in Secondary and Senior Secondary :-</u> The Member secretary informed the VMC Members that Installation of CCTV in almost all Secondary and Senior Secondary classes is to be done through GeM. The worthy members consented for the same.
- e) <u>Purchase of Interactive Panels</u>:-The Member secretary informed the VMC Members thatInteractive Panels for E Class Room have to be purchased. As soon as HQ gives the approval the same will be done. The worthy members consented for the same.
- f) <u>Purchase of Furniture:-</u>The Member secretary informed the VMC Members that Furniture items have to be purchased under PM SHRI Fund through GeM and the required documents were shared with the VMC members. The worthy members consented for the same.
- g) Repairing of class room Furniture items: The Member secretary informed the VMC Members that Furniture items are being repaired in the vidyalaya on a regular basis. The worthy members appreciated the same.
- h) Repair of Xerox Machine: The Member secretary informed the VMC Members that the Xerox machine has been repaired in the Exam Department and printing of Question Papers is being done in the Vidyalaya itself. The worthy members appreciated the same.
