- Each bidder shall submit only one quotation;
- The firm should enclose supporting documents regarding registration of GST.

**5. Evaluation of quotations**

The Purchaser will evaluate and compare the quotations determined to be substantially responsive, i.e., which are:

- a) The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price as per Para 5 above;
- b) The bidder whose bid is accepted will be notified of the award of the contract by the Office prior to expiration of the quotation validity period.
- c) The notification of Ward to clearly specify any change in the unit price or any other terms and conditions accepted.
- d) Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.

You are requested to send the sealed quotations through speed post/registered post only super scribed on the envelope as '**Quotations for Bala Painting**' due on 26-07.2025.
