- Engagement of a teacher shall be made as per the available vacancies as and when required as per KVS rules.
- The candidates engaged on contractual basis, would neither have claim or right for appointment on regular basis nor be a part of the cadre of teachers of Kendriya Vidyalayas.
- Interview is to prepare a panel which will be operated for the year 2025-2026 against any vacancy. Mere placement in the panel does not give any candidate the right for appointment on contract basis, as these appointments are purely need based.
- The candidates should ensure that they fulfill all the eligibility norms before applying for the same.
- Candidates having teaching experience in CBSE pattern will be given preference.
