

The above KVs are instructed to select the children and give them proper training. The letter received from KVS is enclosed for your perusal and necessary action.

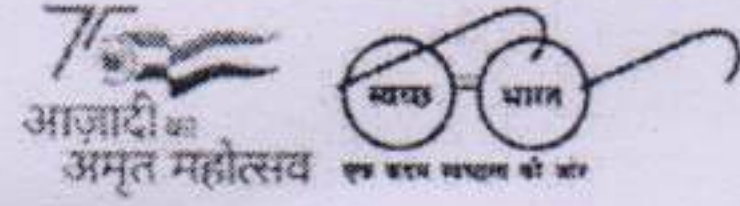


As per the direction of Ministry of Parliamentary Affairs, Government of India vide letter dated 24.04.2024 regarding modalities to conduct of Youth Parliament Competitions 2024-25, it is informed that-

1. 175 Kendriya Vidyalayas across the country including the Vidyalaya, which stood first in the last edition of Youth Parliament Competition, shall participate in the 35th National Youth Parliament Competition 2024- 25.
2. Therefore, each region will sponsor 7 Kendriya Vidyalayas, out of these 3 Vidyalayas should be old participants and 4 should be new participants,
3. The Vidyalayas, which have not participated during the last 3 editions of the competitions, would be treated as 'New Participant'.
4. It has been also informed that Orientation Courses to acquaint the Nodal AC, Principals and Teacher- in charge with the modalities and parameters of the scheme of Youth Parliament Competition, will be held 1<sup>st</sup> or 2<sup>nd</sup> week of July, 2024 in virtual mode.

Further, it is requested to send the list of identified Kendriya Vidyalayas (**Annexure I**) in the Region for the Youth Parliament Competition 2024-25 as per norms to this office through email at [acacadkvs@gmail.com](mailto:acacadkvs@gmail.com) latest by 05.05.2024.



**MODALITIES FOR HOLDING THE YOUTH PARLIAMENT  
COMPETITIONS, 2024-25**

A meeting chaired by Additional Secretary, Ministry of Parliament Affairs (MPA) was held with stakeholders of Youth Parliament Competitions in Room No. S61, Parliament House on 16<sup>th</sup> April, 2024 to discuss modalities for holding Youth Parliament Competition of session 2024-25.

At the outset, the chair welcomed the members and briefed them about the background and context of the meeting. Thereafter, the members discussed the various modalities for organizing Youth Parliament Competitions of session 2024-25. After discussions, following decisions were taken:-

## Youth Parliament Competitions, 2024-25

### 1. Nomination of Schools :-

- i. **Jawahar Navodaya Vidyalayas** : A total of 88 schools under the Navodaya Vidyalaya Samiti(NVS) including the school which stood first in the last edition of the competition shall participate in the 26<sup>th</sup> National Youth Parliament Competition, 2024-25. Each of the 8 regional offices of NVS should sponsor 11 schools.
- ii. **Kendriya Vidyalayas** : A total of 175 Schools under Kendriya Vidyalaya Sangathan(KVS) including the school which stood first in the last edition of the competition shall participate in the 35<sup>th</sup> National Youth Parliament Competition, 2024-25. Each of the 25 regional offices of KVS should sponsor 7 schools, out of these 3 schools should be old participants and 4 should be new participants. Schools which have not participated during the last 3 editions of the competition would be treated as 'new participants'.
- iii. **Delhi Schools** :
  - a. The Directorate of Education, Govt. of NCT of Delhi and NDMC will sponsor 40 schools and 4 schools respectively for the 57<sup>th</sup> Youth Parliament Competition, 2024-25 for Delhi schools. The school, which stood first in the last edition of the competition, will be one of the participants.
  - b. Directorate of Education, Govt. of NCT of Delhi should nominate the schools as per the following guidelines.
    - o At least one school should be nominated from each of the 29 Education Zones to make a total of 40 schools.
    - o 30 Government Schools, 7 Private Schools and 3 Government aided schools should be nominated.
    - o 24 schools should be new schools and 16 should be old schools. Schools which have not participated during the the last 3 editions of the competition would be treated as 'new participants'.

### 2. List of Sponsored Schools:-

Navodaya Vidyalaya Samiti (NVS), Kendriya Vidyalaya Sangathan (KVS), Directorate of Education, Govt. of NCT of Delhi and NDMC should prepare the list of participating schools to participate in the competition, for the year 2024-25, along with the contact details such as full name of the schools with postal address and names of the principals & teachers-in-charge of youth parliament activity with their email, telephone and mobile numbers as per the pro-forma attached. The list shall be sent to the Ministry by 10-05-2024.

### 3. Orientation Course:-

Orientation courses shall be organized to acquaint the Principals and Teachers-in-charge of the participating institutions with the modalities and parameters of

the schemes of Youth Parliament. The orientation courses will be held tentatively on the following dates, subject to administrative exigencies :-

#### 4. Evaluation:-

- i. **Jawahar Navodaya Vidyalayas :-** The Navodaya Vidyalaya Samiti shall complete the regional level evaluations by 15<sup>th</sup> September, 2024 and send the results of the evaluations to the Ministry of Parliamentary Affairs by 20<sup>th</sup> September, 2024. The National Level evaluations will be held by the end of November, 2024. The exact dates and venues for the National Level evaluations shall be decided by NVS (hqrs.) in consultation with the Ministry.
- ii. **Kendriya Vidyalayas:-** The Kendriya Vidyalaya Sangathan shall complete the regional level evaluations by 31<sup>st</sup> August, 2024 and send the results of the evaluations to the Ministry of Parliamentary Affairs by 20<sup>th</sup> September, 2024. The National Level evaluations will be held tentatively in November-December, 2024. The exact dates and venues for the National Level evaluations shall be decided by KVS (hqrs.) in consultation with the Ministry.
- iii. **Delhi Schools:-** The evaluations of the Youth Parliament sittings of the sponsored schools will be held tentatively in the period between September - December, 2024 and will be completed by 31<sup>st</sup> December, 2024.

The meeting ended with a vote of thanks to the Chair.
