- Print out of the Registration Form/ **Application for admission in "PM SHRI KV NO 1, CUTTACK"** (The same was submitted online), Please paste the Passport size photo of the child at the top of this Registration Form.
- Copy of the Date of Birth Certificate – The same which was uploaded in your online Application.
- Copy of the differently abled Certificate (Those selected under DA and for others where applicable)
- Copy of the Caste Certificate (SC/ST/OBC) where applicable. – Certificate in the name of the parent will be accepted initially, but the same in the name of the child should be submitted within three months of admission. An undertaking to this effect should be given (Format enclosed). OBC (NCL) Certificate in the name of the parent's issued by the competent authority on or after **1ST APRIL 2022** will be considered. **(SEBC Certificate will not be accepted in lieu of OBC Certificate).**
- Those claiming their Family income group as Economically Weaker Section (EWS) should submit the valid **"INCOME AND ASSET CERTIFICATE TO BE PRODUCED BY ECONOMICALLY WEAKER SECTIONS"** issued by the competent authority during this Financial Year in the name of either of the parent/Child. (INCOME CERTIFICATE, Ration Card, BPL Card etc. **will not be accepted in lieu of this**).
- Those claiming Below Poverty Line should submit the following documents:
 - (a) BPL Card, if available in the name of the parent of the child, but lapsed as on date, this can be countersigned by the BDO of the locality of rural areas/Executive Officer of NAC of Municipality areas to validate the card along with Low Income Certificate/ EWS Certificate/Labour Card
OR
 - (b) PHH Ration Card (New) + Low Income Certificate/ EWS Certificate/Labour Card
OR
 - (c) Antodaya Anna Yojana Card + Low Income Certificate/ EWS Certificate/MGNREGP Job Card/Labour Card
AND
An Affidavit to the effect that as on date the Parent and his family belongs to BPL Category and Low-Income Group and all information provided about the above documents are correct.
- Copy of the Proof of Residence – As indicated in your Application (Any Govt. approved residential address like Bank Pass Book, Gas Bill, Electricity Bill etc. in the name of either of the parent. In case of Rented House proper RENT Agreement and a copy of the Electricity Bill of the House Owner).
- Service Certificate of parents in **ORIGINAL (Format enclosed)** issued by the competent authority. Photo copy of first page and relevant page of service book to be submitted.
- Last month Pay Slip - For those who have mentioned their Service category as I, II, III, & IV.
- Certificate of number of transfers (Format enclosed) and copy of transfer order (The entries should be as it is mentioned in online application) where applicable.
- Ex-Service Men should submit the copy of their discharge Book and PPO and the Transfer Certificate should be signed by the Rajya / Zilla Sainik Board or any authority competent to issue the same
- Filled in "Declaration of submission of Documents", "Declaration of Distance" Undertaking for Submission of SC/ST/OBC-NCL Certificate in the name of the Child"
- Copy of the Aadhar Card of the Child, Father, Mother (If available)
- Two recent pass port size photographs of the child and blood group report

NOTE: All the photo copies of the documents should be self-attested i.e. signed (Full Signature) by the parent with date.
