The following Concessions will be allowed for Admission for Class XI:

- Concession will be granted to students for admission who participated in Games (A) & Sports meet / Scouting & Guiding / NCC / Adventure activities at various levels. The details are given in the option form. The Certificate needed for this purpose can be of any of the preceding years.
- Students belonging to SC / ST /OBC/ Divyang(PH) would be given up-gradation in (B) aggregate by 04% Marks for the purpose of admission to class XI on production of valid certificate.

Note: Maximum concession under Sports/Games/NCC/Scout/Guide/Adventure will not exceed 06% Marks in aggregate. In case of eligibility for more than one concession under different categories as mentioned at (A) and (B) above, only one concession having maximum advantage to the candidate will be allowed

Code of conduct for students as per KVS education code Article No.60:
