Sir/Madam,

1. Sealed quotations (strictly in the format attached below) for the civil works listed below are invited by the undersigned on behalf of PM SHRI Kendriya Vidyalaya Rubber Board, Kottayam up to 01:00 P.M on 25.10.2025. Quotations should be sent under strong cover marked as 'Quotation for CIVIL WORKS '(Construction/development of Sports Courts)' and not by name. The quotations will be opened in the office of the undersigned at 02:00 PM on 25.10.2025.
2. The quotations shall be submitted according to the terms and conditions specified in paragraphs 3 to 10. Unless specified otherwise in the quotation, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.
3. The rates should be F.O.R. and should include excise duty, sales tax, freight charges, and any other taxes or impositions whatsoever liable in respect of the supplies. The Kendriya Vidyalaya shall not be liable to pay any tax, freight, etc., which has not been expressly stipulated in the quotation in the event of acceptance of the quotation.
4. There should not be any overwriting or corrections in the quotations. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of attested signature, the quotation is liable to be rejected.
5. Comparison of rates by different bidders/contractors/applicants to ascertain the L1 rate will be based on the "Total cost of the work" and not on any part work.
6. The undersigned does not bind himself to accept the lowest quotation and reserves the right to accept the quotation in whole or in part, i.e., with respect to all or any of the works mentioned in the attached statement, as he/she decides.

7. On acceptance of the quotation it will become a contract and the contractor shall be bound by the terms and conditions of the quotation.

8. If the contractor fails to complete the works within the time stipulated in the letter of acceptance, the undersigned shall be at liberty to get the work completed by any other person or firm, and the difference of price, if any, shall be deducted from the earnest money/security deposit, and in case any amount in excess of the security deposit is paid by the undersigned, the contractor shall be liable to pay this amount.

9. The rates quoted by the contractor shall hold good up to 31.03.2026. No amendment in the rate except increase in the rate of sales tax during the period of execution of the contract will be accepted.

10. Quotations which do not comply with the above conditions are liable to be rejected.
