SUB: INVITING QUOTATIONS FOR THE DEVELOPMENT OF PLAY GROUND AT PM SHRI KVKOLLAM

PM SHRI KENDRIYA VIDYALAYA KOLLAM is an autonomous body under the Ministry of Education Govt. of India is an educational institution under Kendriya Vidyalaya Sangathan, a society registered under societies registration act 1860. The Sangathan administers the scheme of Kendriya Vidyalaya set up for imparting education to the children of transferable central Govt. employees among others.

Sir/Madam,

Sealed competitive quotations from firms who have valid license are invited by the Principal, PM SHRI KV KOLLAM for the development of Play Ground of the Vidyalaya as per the scope of work attached.

1	Making boundary with cement brick in the areas around the ground where boundary does not exist, with 6-inch width, 12-inch height (for approximately 150 m length) with suitable provisions for drainage	150 m length approximately
2	Filling the Ground (60 m x 50 m) with good quality soil suitable for football ground soil up to a height of 20 cm (0.2 m)	
3	Paving geo textile over an area of 1000Sqm on four sides of the ground before filling with soil (for a width 5 m from the boundary in side, all around) (60X5x2=600 + 40x5x2=400=1000)	1000 sq m
4	Levelling the soil and Compaction with Road Roller/ Suitable compactors. Slope (1/200) to be towards North- East such that rain water flows and reach the drainage available on North and East sides of the ground	3000 sqm
5	Providing net fencing on both side of the ground (North and east) up to a height of 6 m (One full pipe length) with 1.5 inch GI pipe and net with 3 m gap between the pipes in the Northern side and 4 m gap in the eastern side. Net to be fixed with clamp/ J hook of GI and Pipe to be fixed on the boundary wall with 1.5 inch Clamp with anchor bolt	80 m length

Note: 1. Type of soil will be as per the specifications suggested by the monitoring committee

- 2. Geo textile needs to be of good quality
- 3. The GI pipe used for fencing must be of good quality and to be fixed by concreting with at least 2 feet under the ground / Fixing safely and strongly on the boundary wall around. The net should be of good quality and fixed in the pipes with sufficient clamps.

Terms and conditions

- a) The contract shall be for the Work of the mentioned items above for PM SHRI Kendriya Vidyalaya Kollam. The bidder shall quote the rates for items of work in the attached format.
- b) All taxes, Duties and other levies payable by the bidder, shall be included in the total price. They shall be quoted separately. No additional payment will be done for anything that is not quoted.
- c) The rates quoted for each item by the bidder shall be fixed for the whole duration of the contract, i.e. for one year from the date of award of the contract, as per the scope of work.
- d) The Vidyalaya is free to make the contractor perform the works mentioned from 1 to 5 either together at a stretch or separately as per the availability of fund.
- e) Each bidder shall submit only one quotation only in the same format supplied by the Vidyalaya. No other format is acceptable

- f) Quotations are not acceptable if submitted through e-mail/fax etc.
- g) The bid should be submitted along with EMD for Rs.15000/-(Fifteen Thousand Only) by Bank Draft in favors of VVN Account of Kendriya Vidyalaya Kollam, payable at Kollam. The EMD paid will be refunded in the case of unsuccessful bidders within 90 days from the date of opening of Quotations. (Note: Exemptions as applicable will be given to MSME)
- h) The firm should enclose supporting documents regarding registration of GST/VAT/ST/IT PAN/TAN/MSME Registration Certificates (as applicable) from department concerned without fail.
- i) The entire work to be done with good quality materials and suitable soil of good quality. **The brand** and quality will be tested /verified and has to be approved by the monitoring committee.
- j) The type of soil required to be filled in the ground will be as per the discretion and decision of the Monitoring Committee of the Vidyalaya and will be informed at the time of awarding the contract.
- k) Before filling the soil, tractor/ JCB to be used to loosen the existing soil in the ground to ensure bonding between the old and new soils.
- I) The bidder to bring sample soil to the Vidyalaya for selection and approval.

Validity of quotations

The quotation shall remain valid for a period of one year after the deadline date for the submission of quotations.

Evaluation of Quotations

The purchaser will evaluate and compare the quotations determined to be substantially responsive, ie, which are

- a) Properly signed
- b) Conforming to the terms and conditions and specifications

The evaluation would be done for all the items/services put together. The tender in which any items/services for which no rates have been quoted would be treated as invalid. The bidder who has quoted for partial quantity of any one or more item(s) would be treated as non-responsive. The purchaser shall keep in mind that the rates quoted shall be competitive and do not in any manner whatsoever compromise with the quality of item and services to be provided by him/her as per the terms and conditions. PM Shri Kendriya Vidyalaya Kollam will award the contract to the responsive bidder whose total cost for all the items put together (from 1 to 5) is the lowest in the rate including GST column (column 5 of Annexure -1). However, this does not restrict the purchaser from imposing any further conditions before awarding the contract.

c) The bidder who has quoted for partial work of any one or more items(s) shall be considered as non-responsive.

Award of Contract

a) The purchaser shall award the contract to the bidder whose quotation has been determined to be substantially/technically responsive and whose total sum of unit rates for all the work items (1 to 5) put together in Annexure-1 is lowest. (Total of all rates with GST taken together for units in column 5 of Annexure -1)

Note: Work will be awarded with materials, labour and equipment/ machinery involved.

- b) The bidder whose bid is accepted shall be notified about the award of contract, by the Office, prior to the expiration of the quotation validity period.
- c) Normal commercial warranty/ guarantee shall be applicable to the materials and service provided.
- d) Payment shall be made within 15 days after the submission of original GST bill which is accepted and certified by the Vidyalaya Painting Monitoring Committee in all respect.
- e) Notwithstanding the above the purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

- f) The awardee of the contract shall be liable to compensate the damages caused to the road, building or the materials in the building, if any, during the work. For such damages if any, compensation will be deducted from the payment to be made for the work as per quotation.
- g) Extra care to be taken to ensure that the road doesn't get damage / the tiles do not get broken during the transportation of soil and other machinery for the work. If any damage occur, the bidder shall be liable to compensate or repair the same.
- h) The awardee of the contract shall be liable to pay compensation/penalty if the said work is not completed within the stipulated time.
- i) At no cost the work should affect the safety and security of the students including their movement in the campus.
- j) The successful bidder has to deposit performance security of an amount equivalent to 5% of the total coast of the works in favour of 'Principal Kendriya Vidyalaya Kollam VVN Accont', payable at Kollam, in the form of Demand draft. At the time of making payments of the work, TDS and GST will be deducted @ 2%, as applicable and as per rules.

Additional terms and conditions.

- a) The awardee of the contract shall begin the work only after obtaining the approval of the WORK MONITORING COMMITTEE with regard to the quality of the Material and soil to be used for the work.
- b) The tools / equipments for cleaning, loosening the soil of the existing ground, Compaction etc to be brought by the awardee and the rates quoted should include all these. At no cost, such materials shall be provided by the Vidyalaya.
- c) All the items in the ground (Football Goal Post / any other) shall be removed safely before work g and refixed after the work by the awardee of the contract.
- d) Complete and perfect cleaning of the road shall be done by the awardee after the work.
- e) The awardee of the contract shall be liable to compensate the damages caused to the building, road and any other areas / materials in the building, if any, during the work.
- f) After completion of the said work , measurement is any be taken in the presence of the Work Monitoring Committee
- g) Tax Deducted at Source (TDS) and GST will be deducted as per applicable Rates.
- h) Those vendors who would like to visit the site before submitting quotations to know the details of the work may visit the Vidyalaya on any working day between 9.00 am to 3.00 pm
