### **RECRUITMENT OF VARIOUS TEACHING & NON-TEACHING POSTS IN KENDRIYA VIDYALAYA SANGATHAN AND NAVODAYA VIDYALAYA SAMITI**

Kendriya Vidyalaya Sangathan henceforth mentioned as KVS is an autonomous organization under the Ministry of Education, Department of School Education & Literacy, Government of India. It has its Headquarters office at New Delhi, 25 Regional offices located at Agra, Ahmedabad, Bengaluru, Bhopal, Bhubaneswar, Chandigarh, Chennai, Dehradun, Delhi, Ernakulam, Gurgaon, Guwahati, Hyderabad, Jabalpur, Jaipur, Jammu, Kolkata, Lucknow, Mumbai, Patna, Raipur, Ranchi, Silchar, Tinsukia, Varanasi and 1288 Kendriya Vidyalayas (KVs) functioning all over the country including 03 abroad. It also has five Zonal Institutes of Education & Training (ZIETs). KVs are co-educational schools upto class 12<sup>th</sup> and focuses on holistic development of students.

Navodaya Vidyalaya Samiti henceforth mentioned as NVS is an autonomous organization under the Ministry of Education, Department of School Education & Literacy, Government of India. It has its Hqrs Office at NOIDA (Uttar Pradesh), 08 Regional Offices at Bhopal, Chandigarh, Hyderabad, Jaipur, Lucknow, Patna, Pune & Shillong and 653 Jawahar Navodaya Vidyalayas (JNVs) functional all over India except in the State of Tamil Nadu. JNVs are co-educational, fully residential schools up to Senior Secondary level and are located mainly in rural areas. JNVs being fully residential institutions, the teachers are required to stay in the Vidyalaya campus for which rent-free accommodation as available are provided. In addition to normal teaching duties, the teachers are required to perform responsibilities attached with residential system of schooling like House Mastership, remedial and supervisory studies, organization of co-curricular activities, escorting of students on migration & other official purposes and looking after students' welfare in general. During the period of probation of the incumbent, performance in all these areas will also be assessed, in addition to the teaching ability to determine suitability for the job. In view of the admission policy that at least 1/3<sup>rd</sup> students admitted in JNVs are girls, therefore, efforts will be made to post male and female teachers in proportion to the number of girl students in JNVs and as per administrative need of NVS subject to condition that they fulfill the normal eligibility conditions. However, there is no separate reservation for Female Teachers to this effect.

CBSE (an autonomous organization under the Ministry of Education, Department of School Education & Literacy, Government of India) on behalf of KVS and NVS invites online applications from eligible Indian citizens for recruitment on direct basis for various teaching and non-teaching posts in **Kendriya Vidyalaya Sangathan and Navodaya Vidyalaya Samiti. - g. **Part V (i.e. question no. 81 to 90) of question paper of Tier-1 for all other posts and Part III (i.e. question no. 61 to 80) of question paper of Tier-1 for Multi-Tasking Staff** pertaining to Language Competency Test (English) will be only in English medium.
- h. **Part VI (i.e. question no. 91 to 100) of question paper of Tier-1 for all other posts and Part IV (i.e. question no. 81 to 100) of question paper of Tier-1 for Multi-Tasking Staff** pertaining to Language Competency Test (**\*Modern Indian Language** - Hindi, Assamese, Bengali, Gujarati, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu) will be only in concerned Language opted by the candidates. The option of one of these 12 Language is to be compulsorily filled by the candidates in online application form. The option of language, once filled, will not be changed under any circumstances. During examination, the candidates will have to attempt the questions of Part – VI pertaining to language opted by him/her in the online application form. The details of Language opted by candidates for Part – VI will also be mentioned on their admit card.
- i. Expected knowledge of candidates for Tier–1 for the posts of Assistant Commissioner, Principal, Vice-Principal, PGT will be of Post Graduation level.
- j. Expected knowledge of candidates for Tier–1 for the posts of TGT, Administrative Officer, Finance Officer, Assistant Engineer (Civil), Assistant Section Officer, Junior Translator, Stenographer Grade-II, Stenographer Grade–I and Senior Secretariat Assistant will be of Graduation level.
- k. Expected knowledge of candidates for Tier–1 for the posts of PRT, Junior Secretariat Assistant and Lab Attendant will be of Senior Secondary level.
- l. Expected knowledge of candidates for Tier–1 for the posts of Multi-Tasking Staff will be of Secondary level.
- m. Combined Tier–1 may be conducted for some of the posts; however, based on the performance of candidates, separate post-wise/subject-wise merit list will be prepared. For example, if the combined Tier-1 examination for the posts of PGT, TGT and Hindi Translator is conducted and a candidate who has applied for PGT (Hindi), TGT(Hindi) and Hindi Translator appears in Tier-1, he/she will be placed in merit lists of Tier-1 for PGT (Hindi), TGT(Hindi) and Hindi Translator as per his/her performance in Tier-1. Shortlisting for Tier-2 will be done for each post/subject from such merit.
- n. Tier-1 will be screening test to shortlist the candidates for Tier-2 in the ratio of 1:10 (relative to notified vacancies). Candidates securing marks equal to the last candidate in the range of 1:10 under each category will also be shortlisted.
- o. In Tier-1, each question carries 3 marks. **There will be negative marking for wrong answers in Tier-1; 1/3rd marks (i.e.1 marks) will be deducted for each wrong answer.** Unanswered questions will not be given any marks. There is only one correct response for each question. **Filling up/darkening more than one response in any question will be treated as wrong response and One (01) mark as wrong response will be deducted.**
- p. There is no provision of re-evaluation for objective (OMR based) examination of Tier-1. No request in this regard will be entertained for whatsoever the reasons may be.

- q. **There will be separate Tier – 2 for each post** that will be bilingual i.e. in Hindi & English medium. However, for the post of PGT (Modern Indian Language) and TGT (3<sup>rd</sup> Language), the medium of test will be in language concerned.
- r. Tier-2 for all the posts will be Subject Knowledge Examination (combination of Pen-Paper and OMR Based) as per details mentioned below. The test will be of 2½ hours duration without any time - limit for each part of the test individually.

- s. In objective type question in Tier-2 each question carries 1 mark and **there will also be negative marking for wrong answers; 1/4th marks (i.e. 0.25 marks) will be deducted for each wrong answer.** Unanswered questions will not be given any marks. There is only one correct response for each question. **Filling up/darkening more than one response in any question will be treated as wrong response and 1/4th marks (i.e. 0.25 marks) as wrong response will be deducted.**
- t. There is no provision of re-evaluation for objective (OMR)/written/descriptive examination part of Tier-2. No request in this regard will be entertained for whatsoever the reasons may be.
- u. If any misprinting or ambiguity in any of the question is noticed by the subject experts at the time of verification of challenges of answer keys after conduct of examination, a policy decision will be taken as per the recommendation of subject experts.
- v. For Interview, candidates will be shortlisted from Tier-2 in the ratio of 1:3 (relative to notified vacancies). Candidates securing marks equal to the last candidate in the range of 1:3 under each category will also be shortlisted. For Skill Test (wherever applicable), candidates will be shortlisted from Tier-2 in the ratio of 1:5 (relative to notified vacancies). Candidates securing marks equal to the last candidate in the range of 1:5 under each category will also be shortlisted.
- w. Skill Test for Stenographer Grade-I and Stenographer Grade-II & Junior Secretariat Assistant will be conducted as below:

## **12: PROCESS OF ALLOCATION OF CANDIDATES TO KVS & NVS**

- a. After preparation of merit list, the candidates (who will be in the combined merit list of KVS and NVS for same post or in the merit list of more than one post) will have to mandatorily submit their preference of posts in KVS and NVS in the online portal, link of which will be available for a certain notified period in the online log-in of application form of candidates who will be present in Tier – II and Interview/Skill Test.
- b. The allotment of post and department (KVS/NVS) will be done as per merit and the choice indicated by the candidates on the above link. A candidate will be allotted only one post as per his/her choice filled on the link according to merit (i.e. total marks obtained by candidate) irrespective of the fact that the candidate has appeared in Tier – II and Interview/ Skill Test for more than one post.
- c. The request for change in choice (i.e. preference among KVS and NVS filled in online application) will not be accepted for whatsoever reason.
- d. The candidates who do not fill their choice within the notified period will not be considered in merit and no post will be allotted to them.
- e. The allocation of posting to selected candidates in KVs and NVs will be done by KVS and NVS subsequently.
- f. No waiting list shall be maintained.
- g. **The mode & criteria of selection and eligibility conditions of the applicants for interview/Personal Interaction to the notified posts shall be final and binding. However, CBSE (on behalf of KVS/NVS) may change the mode and /or criteria at any stage of selection, whichever so, for all the notified posts. No correspondence will be entertained in this regard.**

## **13. Important Note(s):**

- a. The examination center for Tier-1 and Tier-2 for the post of Assistant Commissioner (Academics), Assistant Commissioner, Principal and Vice-Principal will be at Delhi/NCR only.
- b. The cities of examination for Tier-1, Tier-2 and Skill Test for the recruitment to the other notified posts will be decided according to number of applicants. The allotment of examination city to the candidates will be done on random basis. The examination body (CBSE) reserves the right to allot a Centre anywhere in India due to administrative reasons. Decision of examination body will be final. The examination city/centre once allotted shall not be changed under any circumstances.
- c. The information related to examination city allotted to the candidates for Tier-1 shall be displayed 15 days before examination on the website of CBSE, KVS and NVS. The admit card with centre details and schedule of examination shall be displayed 02 days before examination on the website of CBSE, KVS and NVS.

- d. Similarly, the information related to examination city allotted to the candidates shortlisted for Tier-2/Interview/Skill-Test shall be displayed 15 days before examination on the website of CBSE, KVS and NVS. The admit card with centre details and schedule of examination shall be displayed 02 days before examination on the website of CBSE, KVS and NVS.
- e. **The e-Admit cards for Tier-I/Tier-II/Interview/Skill-Test will be made available only in the candidates' application log-in. Similarly, the status of shortlisting for Tier-II/Interview/Skill-Test will also be made available only in the candidates' application log-in. No hard copy or email/SMS will be sent to candidates in this regard.**
- f. **The candidates are advised to regularly visit the website of CBSE, KVS and NVS for all updates regarding recruitment process. Neither CBSE nor KVS/NVS will be responsible if a candidate does not regularly visits the websites of CBSE/KVS/NVS. Neither CBSE nor KVS/NVS will provide any update to candidate by replying to their e-mail regarding the conduct of examination separately.**

#### **14. PROVISIONS FOR DIFFERENTLY ABLED CANDIDATES**

- a. A candidate who claims to belong to PwBD category as defined under section 2(r) of the RPWD Act 2016 should submit a copy of the certificate PROFORMA-V-A/PROFORMA-V-B/PROFORMA-V-C (as available in the detailed notification published on CBSE, KVS and NVS websites) and UDID card issued by appropriate issuing authority as per rule on the prescribed in support of his / her claim.
- b. The facility of Scribe/Reader/Lab Assistant would be allowed to any person with benchmark disability as defined under section 2(r) of the RPWD Act 2016 and has limitation in writing including that of speed if so desired by him/her.
- c. In case of persons with benchmark disabilities in the category of blindness, locomotor disability (both arm affected-BA) and cerebral palsy, the facility of scribe/reader/lab assistant shall be given, if so desired by the person.
- d. In case of other category of persons with benchmark disabilities, the provision of scribe/reader/lab assistant can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government health care institution as per proforma at PROFORMA-V-D (as available in the detailed notification published on CBSE, KVS and NVS website).
- e. Centre Superintendent would make reserve panel of scribes based on list of candidates sent to them with centre material and make the scribe available to differently abled candidates as & when required.
- f. While making panel of scribe/reader, it shall be ensured that qualification of the scribe should not be more than the minimum qualification criteria of the post for which the examination is being conducted. However, the qualification of the scribe/reader should always be matriculate or above.
- g. The candidates desirous of using scribe as per norms should meet the Centre

Superintendent to verify the suitability of scribe one day before examination.

- h. In case the candidate is allowed to bring his own scribe, the qualification of the scribe should also be one step below the qualification of the post for which candidate is taking examination. The persons with benchmark disabilities opting for own scribe/reader should submit details of the own scribe as per PROFORMA-V-F (as available in the detailed notification published on CBSE, KVS and NVS website).
- i. In addition, the scribe has to produce a valid ID proof (PAN, Aadhar Card, Driving Licence etc.) in original at the time of examination. A photocopy of the ID proof of the scribe signed by the candidate as well as the scribe has to submit along with proforma at APPENDIX-Q (as available in the detailed notification published on CBSE, KVS and NVS website).
- j. If subsequently it is found that the qualification of the scribe is not as declared by the candidate, then the candidate shall forfeit his/her right to the post and claims relating thereto.
- k. The differently-abled candidates may be given 40 minutes compensatory time for 2.00 hours duration, 50 minutes compensatory time for 2.30 hours duration and 60 minutes compensatory time for 3.00 hours duration in each paper examination on production of disability certificate issued by the Competent Authority. In case, a differently abled candidate is not willing to avail compensatory time, he/she should submit an undertaking to this effect the Centre Superintendent. However, no extra time will be provided during skill test.
- l. There will be separate Question Paper in large font for Visually Impaired candidates. It may also be noted that normal Question Paper shall also be available at the examination centre to Visually Impaired candidates. It is the choice of Visually Challenged candidate to use either of the Question paper.
- m. The differently-abled candidates should bring with themselves the disability certificate on proper format issued by the Competent Authority and it should be produced at the examination centre to avail above relaxation(s). The facility of scribe and/or compensatory time will not be provided to the candidate if he/she is not able to produce disability certificate (on proper format issued by the Competent Authority) before centre superintendent before commencement of examination.
- n. The facility of scribe and/or compensatory time shall be granted to those persons with specified disabilities covered under the definition of Section 2(s) of the RPwD Act, 2016 but not covered under the definition of Section 2(r) of the said Act, i.e. persons having less than 40% disability and having difficulty in writing subject to production of a certificate to the effect that person concerned has limitation to write and that scribe is essential to write examination on his/her behalf from the competent medical authority of a Government healthcare institution as per PROFORMA-V-D (as available in the detailed notification published on CBSE, KVS and NVS website).
- o. No reservation will be given to such candidates, who are having temporary disability certificate.

**15. ROUGH WORK:-**

All calculations/writing work is to be done only in the space available in test booklet. No separate sheet will be provided at the Examination Centre to any candidate.

#### **16. UN-FAIR MEANS:-**

Un-fair Means practice is an activity that allows a candidate to gain an un-fair advantage over other candidates. It includes, but is not limited to the following:

- i. At the time of MCQ/written/descriptive examination, if a candidate is found guilty of using un-fair means or impersonating or misbehaving in the examination hall, wherever applicable, or bringing outside influence on the examination process or resorting to any other un-fair means in connection with his/her candidature for the selection;
- ii. obtaining support for his/her candidature by any other means, such candidate will be liable to criminal prosecution and disqualified from the examination either permanently or for a specified period from any examination or selection of the KVS and NVS in accordance with applicable Laws, Regulations & Rules etc.
- iii. If it is found at any stage that any candidate has furnished any false information/ particulars with regard to his/her qualification, category/caste/PwBD category and experience in the Application Form or in any document and/or misrepresented/suppressed any material information in the application form, for securing appointment in the KVS/NVS, his/her service will be terminated forthwith at any stage in service i.e. during probation period or after confirmation of the service in the KVS/NVS, without assigning any reason thereof.
- iv. Canvassing in any form will be treated as disqualification.
- v. Using someone else to write examination (impersonation) or copying;
- vi. Breaching examination rules or any direction issued by CBSE in connection with examination from time to time;
- vii. Assisting other candidate to engage in malpractices, giving or receiving assistance directly or indirectly of any kind or attempting to do so;
- viii. Threatening/intimidation Contacting or communicating or trying to do so with any person, other than the Examination Staff, during the examination time in the Examination Centre; any of the officials connected with the conduct of the examination or threatening any of the candidates;
- ix. Using or attempting to use any un-fair means in connection with the examination;
- x. Forceful entry/exit from Examination Centre/Hall, Creating obstacles in smooth and fair conduct of examination.
- xi. Being in possession of any item or article which has been prohibited or can be used for un-fair practices including any stationery item (any kind of Paper/ Stationery/Textual material/ printed/ written material), communication device, accessories, eatable items, ornaments or any other material or information relevant or not relevant to the examination in the paper concerned;
- xii. Use or attempting to use of any electronic device (Mobile Phone/Earphone/ Microphone/Pager, Calculator, DocuPen, Slide Rules, Log Tables, Camera, Tape Recorder, Electronic Watches with facilities of calculator, any metallic item or electronic gadgets/ devices etc.) after entering in the Examination Centre;

- xiii. Affixing/uploading of wrong/morphed /blank photographs/signatures on the Application Form /Admit Card/Proforma;
- xiv. Manipulation and fabrication of online documents viz. Admit Card, Self-Declaration, etc.;
- xv. Any other malpractices declared as Un-fair Means by the examination body.
- xvi. If it is found at any time in future that the candidate has used/uploaded the photograph, signature and certificate(s) of someone else in his/her Application Form/Admit Card or he/she has tampered his/her Admit Card, these acts of the candidate shall be treated as Un-fair Means (UFM) practices on his/her part and he/she shall be proceeded with necessary actions under the applicable provisions.
- xvii. Creating disturbance in smooth conduct of the examination at examination centre/venue.

#### **17. PUNISHMENT FOR USING UN-FAIR MEANS PRACTICES:-**

During the course of, before or after the examination if **a candidate is found indulged in any of the above or similar practice**, he/she shall be deemed to have used un-fair means and booked under UN FAIRMEANS (U.F.M.) case, **shall be disqualified for this examination**. The candidate(s) may also be debarred for a period of 02 (two) years from future examinations of recruitment in KVS and NVS. The candidate shall also be liable for criminal prosecution action and/or any other action as deemed fit under relevant provisions. **The result of the candidate(s) who indulge in Un-fair-means Practices will be cancelled and will not be declared.**

#### **18. DISPLAY OF SCANNED IMAGE OF OMR ANSWER SHEET AND ANSWER KEY:-**

In case of Objective Type (MCQ) Tests of Tier-1 and Tier-2, the scanned copy of OMR answer sheet and the Answer Keys of examination will be displayed on website of CBSE, KVS and NVS for which a public notice will also be issued on the websites. The candidates may download the same within the stipulated time as notified in the Public Notice. The Answer Keys are likely to be displayed for two to three days to provide an opportunity to the candidates to challenge the answer(s) with a non-refundable prescribed fee of Rs.1000/- per question as processing charges, in case they are not satisfied with any of the answer(s). The challenges received against the provisional answer keys within stipulated time will be placed before the subject expert for finalization of answer keys. Challenges without payment of fee and those submitted on any other medium (viz. email/letter/representation) will not be considered. The subject experts will examine all the challenges received and then the final answer keys will be prepared by them. The decision of subject experts on the challenges shall be final and no further communication will be entertained. If the challenge of answer key is accepted by the subject experts i.e. if any mistake is noticed by the subject expert(s) in the answer key, the fee shall be refunded to the candidates who have submitted such claim. The candidates will not be informed individually about the status of their challenges. The result will be declared according to the final answer keys prepared by the subject experts.

**NO GRIEVANCE WITH REGARD TO ANSWER KEY(S) AFTER DECLARATION OF RESULT WILL BE ENTERTAINED.**

#### **18. HOW TO APPLY:**

1. **The candidates should apply only through the official websites of CBSE , KVS and NVS i.e. <https://www.cbse.gov.in/> <https://kvsangathan.nic.in/> and <https://navodaya.gov.in/> respectively. The application forms submitted on any other**

**website/link will not be accepted. The applications submitted by other means/ mode will not be accepted.**

2. **Only Indian nationals are eligible to apply.**
3. A candidate should submit only one application for as many posts he/she wish to apply. There will be drop-down for all the posts mentioned in the notification and the candidates will have to select the posts for which they want to apply. In case a candidate selects more than one post, he/she will have to pay the requisite fee separately for all the posts applied by him. However, within PGTs, a candidate shall apply only in one subject/post irrespective of the fact that he/she fulfills qualifications in more than one subject. Similarly, within TGTs, a candidate shall apply only in one subject/post irrespective of the fact that he/she fulfills qualifications in more than one subject.
4. In case a candidate submits separate applications for different posts, he/she may be allotted different examination centre/city for which neither CBSE nor KVS/NVS will be responsible and the request for allotment of same examination centre/city will not be entertained for whatsoever reason.
5. Multiple applications submitted by any candidate (if detected at later stage) for a post may be cancelled and fee paid by such candidates will be forfeited.
6. Candidates are required to have a valid personal email ID and mobile number. Candidates are advised not to share / mention e mail id/ log in credentials to/of any other person under any circumstances. Both email id and mobile number should be kept active during the currency of this recruitment so as to receive important message(s)/email(s), if any, sent by CBSE/KVS/NVS from time to time.
7. In case a candidate does not have a valid personal email ID, he/she should create his/her new email ID before applying online.
8. The candidates will have to register themselves on the application portal and create their Login-id & password before proceeding to fill online application form. Candidates are advised to note down their login-id and password for future use and keep it safely.
9. The candidates should fill all the particulars in online application form very carefully. Scan and upload their recent photograph and signature at the appropriate places as per instructions contained in the online application form and submit the same online. No modifications are allowed once the online application form is submitted. If any discrepancies are found in the data/information filled by the candidate in online application and the original testimonials, his / her candidature is liable to be rejected.
10. The name of the candidate, date of birth and his/ her parents' name etc. should be spelt correctly in the application as it appears in the class X certificates/mark sheets. At the time of filling the online application, candidates are advised to fill their particular i.e. name, father's/mother's name, date of birth, caste, gender correctly. After the examination or at the time of interview, the request for change of particulars especially for change of category/sub-category will not be entertained by CBSE or KVS/NVS.

12. In case a candidate is applying for similar post in KVS and NVS both, he/she will have to pay fee for single post.
13. No examination fee is required to be paid by candidates belonging to SC/ST/PwBD and Ex-Servicemen category. However, the processing of Rs.500/- will have to be paid by each and every applicant.
14. GST as applicable will be charged extra by the Bank.
15. Before applying online please ensure to have following documents/files:
  - Scanned image of latest photograph in JPG/JPEG format only, for uploading.
  - Scanned image of signature in JPG/JPEG format only, for uploading.
16. Mode of Payment: By Online-mode (Payment by Debit Card/Credit Card/Net Banking) using online gateway payment facility,
  - a) If decided to pay fee through Debit/Credit Card, check the validity of the Card and keep it ready with you while logging on to website for submitting application form.
  - b) Once the payment has been confirmed by the Bank/NIC, a confirmation page will be generated.

21. Incomplete On-line application, in any manner (for whatsoever reason) shall be summarily rejected and no further correspondence shall be entertained.
22. The printout of application form should be sent neither to CBSE/KVS/NVS nor to any other address. The application printout will have to be submitted during document verification at the time of interview along with the self-attested copies of certificates in support of Age, Qualification, Experience, Caste, Caste Validity, Non Creamy Layer, Physical disability, EWS etc. as applicable.

Madam/Sir,

Inviting your attention to the subject cited above, I am to convey the decision to start one section of Balvatika-3 class (for children of 5+ years of age) in the identified 450 KVs (as per the list given in Annexure-I) from the current Academic Session 2023-24. In this regard, the following guidelines are required to be followed and therefore, necessary directions be issued to the Principal of concerned KVs to take necessary for immediate action at their end:

**I. Admission in Balvatika-3 :-**

- Admission to Balvatika-3 class alone shall be done as per the priority and reservations given in the KVS Admission Guidelines 2023-24. The prescribed age criteria is given below:

Class	Age ( as on 31 <sup>st</sup> March 2023)
Balvatika -3	Should have attained 5+ years but not completed 6 years of age.

- Reservation under the provisions of RTE Act-2009 shall be applicable for Balvatika-3.
- Provision for admission for Single Girl Child Category shall not be applicable to Balvatika -3.
- Local advertisement shall be issued by the respective KVs and would ensure wide publicity in their locality.
- Notification, registration and admission will be done as per the Admission Schedule (Annexure-II) attached.

- Registration for admission in Balvatika -3 will be done through Online mode. Registration link, schedule for draw of lots and other details will be issued separately.
- II. Engagement of Teachers & Caregivers (Helpers) :** - Following modalities shall be followed for the engagement of teachers on contractual basis and Caregivers (Helpers) for Balvatika-3.
- A total of 02 ECCE trained Balvatika Teachers shall be engaged on contractual basis by each KV.
  - The engagement of such teachers on contractual basis shall be made as per the instructions contained in this office letter dated 08.10.2013 and their remuneration shall be paid as per this office letter dated 21.03.2013 (similar to that of Primary Teachers)
  - Qualification for Balvatika Teachers as prescribed by NCTE is given below:
    - i. Senior Secondary class (Class XII or its equivalent) from a recognised Board with at least 50% marks **and**
    - ii. Diploma in nursery Teacher education /Pre -school Education /Early Childhood Education Programme (D.E.C.Ed) of duration of not less than two years or B.Ed (Nursery) from NCTE recognised institutions.
  - One Caregiver shall be engaged by each of the KV for Balvatika-3.
  - Caregivers (helper) shall be engaged through the process of outsourcing.
  - Qualification for caregiver or helper shall be as prescribed by NCERT/ NCPCR.
    - i. Secondary class (Class X or its equivalent) from a recognised board, minimum 18 years of age and should have induction training in pre-school Education. Or Any person possessing skill training /adequate training as prescribed by NIPCCD, NSDC or any other institution recognised by the central Government/appropriate Government/Recognised University/Board.
  - Salary for helpers shall be as per the rates applicable for semi-skilled persons.
- III. Class rooms, furniture and other resources:**
- The identified class room shall be made as attractive and colourful to motivate the children.
  - Age appropriate furniture shall be procured by the respective KVs following GFR 2017. The KVs may either opt to have hexagonal tables and chairs or any other suitable design as deemed fit. However, it should be ensured that these are safe for the usage by children.
  - Further, Smart class facilities including good audio systems, other Teaching Aids, Storage Facilities. etc shall be made available in each of these classes.
  - Initially, a sum of Rs 2,50,000/= (Rupees Two lakh Fifty Thousand only) shall be made available as initial grant from KVS (HQs) to govt-funded KVs towards these expenditures.

**IV. School Timing, Fees & others :-**

- Duration of the school timings would be 03 hrs per day on a five-day week basis and the actual timings would be decided by the respective Vidyalayas.
- Vacation and breaks shall be as per the existing schedule.
- No uniform has been prescribed for the Balvatika classes.
- Fee structure shall be similar to existing Class I as per this office letter dated 31.03.2013. It will be collected through UBI portal only.
- Curriculum and resources prescribed by NCERT would be used for Balvatika-3. Academic resources for Balvatika classes have been shared by this office letter dated 24.11.2022.


