

### OFFICE ORDER

**Subject: Utilization of Swimming Pool and Gym Facility through Service Provider – reg.**

In pursuance of the agreement executed with the operating agency, M/s. Som Build-Tech Swimming pool, for management and operation of Swimming Pool and Gym facilities in the Vidyalaya, the following terms and conditions shall be applicable for utilization of the said facilities:

- Eligibility:** All students and staff members of PM SHRI Kendriya Vidyalaya, Sector-3, Rohini are eligible to utilize the Swimming Pool and Gym facilities as per the terms of the contract.
- Fees:** No user charges/fees shall be levied on students and staff members of the Vidyalaya for use of the Swimming Pool and Gym facilities.
- Safety & Security:** The service provider shall be fully responsible for ensuring the safety and security of all users of the facilities. Necessary safety measures, supervision, and emergency protocols must be strictly adhered to.
- Certifications & Compliance:** The service provider shall ensure that all required licenses, safety certifications, and statutory compliances (as applicable) are obtained and kept updated for verification by KVS authorities at any time.
- Provision of Staff:** During the utilization of the facilities, qualified coaches, instructors, lifeguards, and supporting staff shall be provided by the service provider **free of cost**.
- Female Staff Provision:** Female coaches/instructors shall be mandatorily provided for girl students and female staff members.
- Operating Agency Details:** The Swimming Pool and Gym facilities shall be operated and maintained by M/s Som Build-Tech Swimming Pool as per the contractual agreement.
- Agreement Validity:** The agreement is valid for a period of 30 years w.e.f. **19.12.2003**, unless terminated earlier as per contractual provisions.
- User Instructions:** All students and staff members shall strictly follow the safety instructions and guidelines issued by the instructors/coaches while using the facilities.
