POINT NO 3: AGENDA- 1- Apprising the VMC about Academic and other issues:

Following academic/other issues were discussed in the meeting:

- In order to improve the result of the school, remedial classes for the students of class IX to XII were conducted during Autumn Break and Winter Break 2025-26. The school is thankful to WCL authorities for providing bus facilities for the remedial classes during the holidays.
- 55 students of the school participated in Regional Level Youth Parliament Competition held at KV OF Khamaria Jabalpur in August 2025 and secured second position at the regional level.
- Annual Sports Meet was organized on 09th December 2025.
- Newly constructed Badminton Hall was inaugurated on 31st October 2025 by Hon'ble AGM Pench Area WCL and Chairman VMC KV Barkuhi.
- Grand Parents' Day was organized on 05th December 2025.
- Children's Fete was organized on 14th November 2025.
- Students performed fairly well in Regional Kala Utsav/EBSB (by NCERT) & Sansad Cup Sports Events.
- 9th Edition of Pariksha Par Charcha 2026 was organized from 12th January 2026 to 23rd January 2026. One student of the school secured second position in PPC Quiz Competition held at K V 1 Chhindwara on 23rd January, 2026. 100 students from various CBSE/State schools took part in the competition.

Finally, the principal and member secretary Sh. Surya Pratap Singh assured all the members to continue the best possible efforts for an even better participation and efforts in the session 2026-27.

Hon'ble Chairman appreciated the staff for improvement and also the efforts made by the Vidyalaya and assured to provide full support to Vidyalaya in every aspect of development. The assurance was also given to take up the remaining/pending works as early as possible.

8. POINT NO 11 : AGENDA-9- Increasing the height of the protecting wall & gates behind new school building/ Children's Park for protection from any thefts/unauthorized entry.

The proposal was approved by the VMC and the school was informed that this work will be undertaken by the WCL at the earliest possible.

11. Any other issues with the permission of the chair:

A proposal to set up 02 (two) open gyms (For Secondary & Primary students) was accepted by the VMC. It was decided that this work will be undertaken by the WCL in next few months.

- Fr. Jaison. P, Principal of St. Chavra National Academy, Chandametta appreciated the positive growth and the efforts being made for the upliftment of the school. He conveyed his best wishes for the coming board exams.
- Mr. B. Pandurangan, AFM, Pench Area, WCL asked the principal to send the proposals of the works to be undertaken. He asserted that no works will remain pending for want of funds.
- Mr. Hukma Ram, SO (Civil) assured to take up the pending works and the new proposals.
- The parent members expressed their satisfaction over the academic activities of the school. They requested the WCL authorities to provide the 36 e- classroom materials along with 02 separate interactive touch panels for the Bal Vatika classes to the school, as per the long pending demand.
- Hon'ble AGM & Chairman, VMC, Sh. Laxmikant Mahapatra, in his address, asked the Principal to conduct various science exhibition related activities & library activities, and preserve their photographs. He also emphasized that industrial excursions should be conducted for the students with a purpose of a vocational exposure. He asked the Civil Deptt, WCL to explore the possibilities of fixing solar panels and water harvesting system in the school.
- At the end, members of the VMC appreciated all the efforts being made towards the upliftment of the Vidyalaya.
- After a comprehensive and fruitful discussion, all the respected members agreed to meet for the next VMC. At the end, Mr. Abhilash Thakre, VP, KV Barkuhi proposed the vote of thanks to the chair and all distinguished members for their time and valuable suggestions.
