- Offer of admission to the Candidates failing to provide supporting documents required for admission (as per information uploaded in online admission portal) will stand cancelled and no appeal against such action will be entertained.
- Out stationed parents' cases normally may be rejected in categories under transferable Govt employees. Otherwise they have to submit document proof for their claim in Pondicherry station.
- The following documents should be produced in original (along with photo copy self- attested by parents) at the time of admission:
 - Print out of online application form and acknowledgement for registration. One passport size photo (taken in last 6 months) must be pasted at relevant space provided.
 - Date of birth certificate of Child.
 - Proof of residence from the competent authority. Those who are staying in government accommodation to bring staff-quarter allotment order. All others may bring any of the following as proof of residence: - Ration

card/electricity bill/postpaid phone bills/document on gas connection/house tax receipt/Aadhar card/proof of residence from the competent revenue authority.

d. Caste certificate (SC/ST/OBC-NCL) in the name of child. If same could not be produced in the name of the child, an undertaking to be submitted in the effect that the same may be produced within three months from the date of admission. OBC-NCL parents to submit valid certificate as per the State Government's latest norms in the name of the child.

e. EWS/BPL candidates to produce proof of such claim from the competent authority i.e. Tahsildar or above ranked Revenue officers.

f. Service certificate signed by competent authority (in format provided at KVS online Admission Portal) to be produced for proving service category as per KVS admission guidelines.

h. Transfer details including the transfer orders in case of service category I to IV.

Note: All the candidates are expected to take admission on the stipulated dates itself.
