Registration will be from 02.04.2025 to 11.04.2025. Admission will be done as per priority category and reservation criteria as per Kendriya Vidyalaya Sangathan Admission Guidelines 2025-26. Application forms can be obtained free of cost from the school from 10:00 am to 12 noon.

### **DOCUMENTS REQUIRED :**

1. Birth certificate
2. A certificate that the child belongs to the Scheduled Caste/Scheduled Tribe/EWS/OBC (Non-Creamy Layer)/BPL wherever applicable, issued by the Competent Authority in concerned State Government/Union Government

3. A service certificate showing the number of transfers during the preceding 7 years duly signed and stamped by the head of office bearing the name, designation and other relevant particulars in block letters.

4. Proof of residence

5. Aadhar Card (parent & child)

6. Passport size photo of child.

**FRESH ADMISSION FOR CLASS X AND XII:**

a) The child has been in the same course of studies i.e. in a CBSE affiliated school.

b) For Class X, the child must have obtained not less than 55% marks in aggregate in class IX.

c) For admission to class XII, 55% marks in class XI examination is mandatory.

d) The child should otherwise be eligible as per KVS Admission

Guidelines.

e) The combinations of subjects opted by the student are available in the concerned Kendriya Vidyalaya.

f) Fresh Admission will be for Priority category I and II only.

**NOTE:**

Registration forms complete in all respects and accompanied by all required documents must be submitted/sent to the Vidyalaya concerned within the prescribed date as per notification of the KVS.

Self-Attested copies of the prescribed documents would be required to be submitted along with the application form for registration
