

NOTICE

Admission to Class-XII (Commerce) against Vacant Seats for the Session 2026-27

Date:12.05.2026

It is hereby informed to all concerned parents/students that a few seats are presently vacant in **Class-XII (Commerce Stream)** for the academic session **2026-27** in PM SHRI KV No.-02, CRPF Campus, Bhubaneswar. The admissions will be granted strictly as per the provisions contained in the **KVS Admission Guidelines 2026-27**.

At present, **06 (Six) seats** are vacant in Class-XII Commerce; however, the number of vacancies may increase or decrease due to transfer in/out during the admission process.

**I. Eligibility Conditions for Admission in Class-XII (Commerce)**

Fresh admission in Class-XII, other than KV students, shall be considered subject to availability of vacancies i.e. the average class strength is below 40.

**II. The applicant must fulfill the following conditions:**

1. The student must have studied in the **same course/stream** in a **CBSE affiliated school**.
2. The student must have secured a minimum of **55% marks in Class-XI examination**.
3. The student must otherwise be eligible as per KVS Admission Guidelines.
4. The subject combination opted by the student must be available in the Vidyalaya.

We have following subject combinations in XII(Commerce)

5. There should be **no break in continuous study** after passing Class-XI.

**III. Priority Categories for Admission**

As per Para-3(A) of KVS Admission Guidelines, admission shall be considered only for the following categories in Civil/Defence Sector Kendriya Vidyalayas:

**(a) Category-I:** Children of Transferable and non-transferable Central Government Employees including Ex-servicemen.

**(b) Category-II:** Children of Transferable and non-transferable employees of Autonomous Bodies/Public Sector Undertakings/Institutes of Higher Learning of Government of India

Preference in admission shall be regulated as per KVS priority norms and transfer counts, wherever applicable.

**IV. Documents Required:** Applicants must submit self-attested copies of the following documents along with the application form:

- a) Mark Sheet of Class-XI

- b) Transfer Certificate (TC) /Bonafide Certificate
- c) Service Certificate of Parent
- d) Transfer details certificate (last 7 years, wherever applicable)
- e) Proof of Residence
- f) Caste Certificate (SC/ST/OBC-NCL), if applicable
- g) CwSN Certificate, if applicable
- h) Aadhaar Card of Student
- i) Passport size photograph

Incomplete applications are liable to be rejected. Mere registration does not confer any right to admission.

#### V. Admission Procedure

- a) Admissions will be granted strictly on **merit-cum-priority basis**.
- b) In case the number of eligible applicants exceeds available vacancies, merit will be prepared on the basis of marks obtained and KVS admission priority rules.
- c) The Vidyalaya reserves the right to verify all certificates/documents submitted by applicants.
- d) Admission obtained on the basis of incorrect information/documents shall be cancelled anytime and the parent/student shall be held responsible.

- a. Issue of Registration Forms : 12.05.2026
- b. Last Date for Submission of Forms : 20.05.2026
- c. Display of Merit List : 20.05.2026
- d. Admission Completion : 20.05.2026

Application forms may be obtained free of cost from the Vidyalaya Office on all working days w.e.f. 12.05.2026 to 20.05.2026 between 10.30am-12.30pm.
