REQUIRED DOCUMENTS	Documents Required: <ul style="list-style-type: none"> ● Birth Certificate (issued by a competent authority such as Municipality, Panchayat, Military Hospital, etc.). ● AADHAAR Card of the Child and Parent ● Proof of Residence (Aadhaar Card, Ration Card, Voter ID, Passport, Electricity/Water Bill, etc.). ● Distance of Residence for RTE admission - The Children residing in Delhi within a radius of 3 to 5 Km from President's Estate will be considered eligible. ● Social Category Certificate- Recent (Not More Than Six Months Old) (if applicable) for SC/ST/OBC (Non-Creamy Layer)/EWS/BPL, issued by the competent government authority. ● Certificate for Children with Special Needs (CwSN) (if applicable), issued by a civil surgeon or competent authority. ● Service Certificate (for Grandparents working in Rashtrapati Bhawan) ● Transfer and Service Certificate (for parents in government service), indicating the number of transfers in the last 7 years and duly signed and verified by the competent authority ● Retirement Certificate (for uniformed Defence employees (ARMY, AIRFORCE, NAVY), if applicable). ● Latest Passport-size Photograph of the child. ● Blood Group of the Child
Important Note	<ul style="list-style-type: none"> ● Dr. Rajendra Prasad Kendriya Vidyalaya has its own Admission Guideline. ● All admission in Dr. Rajednra Prasad Kendriya Vidyalaya will be done as per Admission Guideline of Dr. RPKV. ● Parents will be solely responsible for any wrong information filled in the registration form. ● All certificates like Caste Certificate (OBC-NCL) and EWS Certificate must be correct AND duly issued by the competent authority. ● Government Service parents must produce a VALID document indicating their Number of Transfer in the last 7 years during the registration process. ● Meaning of TRANSFER: An employee would be treated as transferred only if she/he has been transferred by the competent authority from one place/urban agglomeration to another place/urban agglomeration which is at a distance of at least 20 Kms and minimum period of stay at a place should be of six months/180 days (including the day of relieving). ● All parents/guardians are kindly advised to keep all documents ready prior to filling the registration form.
