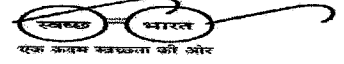

N.B. 1. It may be ensured that the teacher with the longest stay in the KV may be nominated on the recommendation of VMC by rotation for one year.

2. The Principal may keep a note of the date of expiry of the VMC and may submit the proposal in accordance with the guidelines issued from time to time so that the next VMC may be constituted in time.

3. The parents of the two children may be nominated by the Chairman of VMC till the beginning of the next academic session and not for one year as it is likely that in some cases the students may not be on the rolls of the KV for the whole year.
