1. The tenders should be submitted in sealed covers. Open tenders will be rejected.
2. The materials offered for disposal is on "AS IS WHERE IS & WHAT IS BASIS" Ex-godown in unpacked condition. Taxes & duties that may be levied by the Govt. will be extra as applicable and shall be borne and deposited by the highest successful bidder before lifting of material. GST as applicable will have to be deposited by the highest bidder over and above the bid amount before lifting the material(stores).
3. The purchaser may inspect the material on any working day between 15.01.2026 to 21.01.2026 from 1200 Hrs to 1500 Hrs. with prior appointment, Principal tele 01952-235893, to satisfy themselves about the quality & condition of the materials offered. No complaint whatsoever will be entertained after the tenders are submitted or before or after materials are lifted. No request for samples or inspection after submission of the tender will be accepted.
4. Tenders/ Bidders should clearly quote their rates in the prescribed format (Annexure – B) for One Single lot in Complete and not items wise as asked for both in figures and in words exclusive of any taxes and duties. Any overwriting in rates or any change and/or alteration without attestation is liable to culminate in the outright rejection of the tender. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.
5. Tenders should be valid for a period of 45 (Forty five) days from the date of opening of the tenders.
6. Earnest Money deposit of Rs. 5,000.00 ( Rupees Five Thousand only) should be deposited in the shape of Demand Draft payable in favour of PM SHRI KV No.1 Srinagar along with complete Tender Documents. Tenders not accompanied by EMD will be rejected. No interest will accrue on the EMD so deposited.
7. The Highest acceptable responsive bidder (H-I) shall deposit the balance money less the EMD already deposited, within 5 days from the date of issue of award letter by way of Demand Draft in favour of "PM SHRI KV NO.1 Srinagar" or RTGS/NEFT in Bank Account (detail given at Sr. no. 20) . The Demand Draft deposit receipt will be presented to the Office for delivery of the goods.
8. The material has to be got lifted within 03 working days (except Saturday/Sunday/Holiday) after making of full and final payment by the highest successful bidder (H-I). In case the store is not lifted within the time specified, ground rent of Rs. 1,000/-(Rupees one thousand only) per day will be charged from the purchaser for a further period of 7 days. The materials not so removed will be treated as abandoned lots and the EMD and other sums paid for the lot will be forfeited without any reference to the purchaser.

9. For such abandoned lots, the KVS reserves the right to re-sell.
10. The materials will be allowed to be lifted between 11:00 AM to 3.30 PM on any working days. No picking, choosing or sorting will be allowed in the premises for the disposal lots. No lifting and cutting of material will be allowed on holiday /Saturday/Sunday in any circumstance.
11. Mis-description or error in quantity will not invalidate a sale. A proportionate refund will be made to the purchase when the weight or number delivered is less than that have been specified in the tender.
12. Labour, transport and other arrangements will have to be made by the purchaser at their risk, cost and responsibility.
13. The person authorized by the purchaser will be allowed to take delivery.
14. The Vidyalaya reserves the right of withdrawing from the sale of any material or lots at any stage without assigning any reasons thereof.
15. The address given in the tender shall be deemed to be the Purchaser's address and correspondence sent on that address shall be considered to have been delivered to the purchaser. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is returned back undelivered.
16. The material will be disposed off in a single lot and the bidders will have to submit price for complete lot.
17. The tenders duly completed as per the instructions given herein will be delivered latest 23.01.2026, upto 1500 Hrs. All the bidders shall ensure compliance with the provisions contained in E-Waste (Management) Rules-2016 and guidelines issued by the Govt. for disposal/recycling in an environment friendly manner and any other notifications notified thereafter by the Govt. Of India/State Govt./ Union Territory.
25. All questions, disputes or differences arising under and out of or in connection with the disposal of Condemned items, shall be referred to sole arbitration by an arbitrator appointed under the provisions of Indian Arbitration Act by KVS.
26. Any effort by a bidder's agent/ Consultant or representative to influence KVS in any way concerning scrutiny / consideration/ evaluation/ comparison of the bid or decision concerning award of contract shall entail rejection of the bid.
27. Telephonic / Fax/ e.mail / open price bid shall not be acceptable.
28. Late Bids shall be summarily rejected.
