*** Special provision - Relaxation of B.Ed. qualification.-** In the absence of suitable candidates with B.Ed. Degrees in Hard /Very Hard station and in remote areas of North -East and J& K, candidates with following qualifications may be considered in different categories without B. Ed qualification- a) b) c) Post Graduate with 60% marks in Science subjects and 55% in Humanities subjects may be considered for the posts of PGTs, if suitable candidates with B.Ed. are not available Similarly in the case of TGT, B.Sc. with 60% marks and BA with 55% marks may be considered for appointment on part-time contractual basis if suitable candidates with B.Ed. are not available. Graduates may be considered for the post of Primary Teacher if candidates with Senior Secondary/Plus 2/ Inter with J.B.T. qualifications are not available.

Relaxation in CTET - In the absence of TET qualified candidates, candidates without CTET qualification may be considered If otherwise eligible as per KVS recruitment rules.

TERMS & CONDITIONS

2. Candidates will be permitted for appearing in the walk-in-interview only after the verification of documents.
3. Candidates found with minimum essential qualification for the applied post during the document verification process will be allowed to appear in the walk-in-interview. Merely included in the document verification process will not be deemed as a right to appear in the walk-in-interview.
4. Candidates applying for various posts, must fill separate application forms for each post along with attached documents and will appear in the interview separately for the said post(s) as per the date and time mentioned in the advertisement.
5. Candidates must report at 08:00 am on the day of interview along with the duly filled application form with two sets of self-attested photocopies of all documents and originals for verification.
6. No TA/DA is admissible for attending the said walk-in-interview.
