All the interested registered E-waste re-cyclers/ dismantlers/ Pre-processor of E-waste with MOEF/ Central Pollution Control Board, Govt of India or with the state Pollution Control Board or State Govt. dealing with e-waste ( for computer scrap) persons/ parties/ firms are hereby informed to participate for bidding in the campus of PM SHRI Kendriya Vidyalaya No.1 Itanagar, Naharlagun, A.P-791110.

Interested parties may submit their duly filled details by mail to [1itanagar1472@gmail.com](mailto:1itanagar1472@gmail.com), or at Vidyalaya Office as prescribed in Annexure-II on or before 07.03.2025 by 3 PM.

The lowest bid amount/ reserve price may be decided by the undersigned for each article at the time of auction. The items will be handed over to the highest bidder on "as is and where is basis". The highest bidder will have to deposit the full amount at the completion of the bid process in the Vidyalaya within 2 working days. 
### **Eligibility criteria:**

- 2.The Participant should not have been blacklisted by any Department of the Government of India or of any State/ or by any PSU/ Autonomous Organization of Government.

## **General terms and conditions:**

1. The Participants may inspect the items on the prescribed dates and satisfy themselves with the items they are bidding for w.e.f 26.02.2025 to 07.03.2025(1400 hrs to 15:00hrs except Sundays).
2. The items would be sold to the firm that quotes the highest amount.
3. An Earnest Money Deposit (EMD) of Rs.10,000/- (Rupees Ten Thousand only) in form of Demand Draft/ online mode in favour of "Principal, Kendriya Vidyalaya No.1 Itanagar, Arunachal Pradesh" before participating in the bidding process.
