## **WALK-IN INTERVIEW NOTICE 2025-26** **For Engagement of Teachers on Contract Basis**

A walk-in interview will be conducted on **24<sup>th</sup> March 2025** to prepare a panel of **Part Time Contractual Teachers** for the session **2025-26** for the subjects detailed below:

### **1. Post Graduate Teachers (PGT) - English, Hindi, Maths, Political Science**

**Qualification:** Master's Degree or equivalent in the concerned Subject with at least 50% marks and B.Ed. (as on date of application).

**Remuneration:** Rs. 32,500/- per month on pro-rata basis.

### **2. Trained Graduate Teachers (TGT):**

**a. Qualification:** Bachelor's Degree with at least 50% marks in the concerned subjects/ combination of subjects and in aggregate. Subject-wise details are given as under:

(i) TGT (Sanskrit): Having respective subjects in all the three years of Degree Course.

**b. Preference** will be given to candidates who have passed the CTET-II conducted by CBSE in accordance with the Guidelines framed by the NCTE for the purpose.

**c. Remuneration:** Rs. 31,250/- per month on pro-rata basis.

### **3. Primary Teachers (PRT):**

**Qualification:** Senior Secondary School Certificate or Intermediate with 50% marks or its equivalent & Pass in the Central Teacher Eligibility Test (CTET-I conducted by the CBSE in accordance with the Guidelines framed by the NCTE for the purpose or JBT / B.El.Ed / D.El.Ed. Competence to teach through Hindi & English media.

**Remuneration:** Rs. 26,250/- per month on pro-rata basis.

**4. Relaxation:** Where suitable CTET or B.Ed or B.El.Ed or D.El.Ed candidates are not available for PGTs, TGTs and PRTs, such may be relaxed as per EXTANT RULES OF KVS.

### **5. Computer Instructor:**

**Qualification:** B.E/B.Tech (Computer Science/IT) or Post Graduate Degree in Computer Application/MCA/IT or Post Graduate diploma in computer application(PGDCA) or BCA/ B. Sc(CS/IT)/M.Sc(CS/IT) or DOEACC 'A' level with PG degree in any subject from Govt. recognized institution or equivalent qualification. Preference will be given to those who have training & experience in hardware.

**Remuneration:** Rs. 31,250/- per month on pro-rata basis.

### **6. Educational Counsellor:**

**Qualification:** BA/B.Sc in Psychology and one year Diploma in Counselling.

**Desirable** – Minimum one-year experience in providing career/educational counselling to students at schools or experience/ knowledge of working in placement bureaus or registration with rehabilitation council of India as vocational counsellor.

- 1) **Desirable for All Posts:** Knowledge of Computer Applications and proficiency to teach in English and Hindi.
- 2) **Registration for Walk-in Interview:** Only Online Registration will be accepted. If the
- 3) Candidates having requisite qualification only, are to submit their application through online registration only. Separate form must be submitted for each post along with Bio-Data (proforma may be downloaded from the Vidyalaya website) mentioning contact Number & Residential Address clearly. Self-attested photocopies of all certificates and testimonials are also to be submitted along with the form on the date of Interview.
- 4) Panel for contractual teachers of various subjects will be prepared on the basis of performance in the interview and selected teachers will be called for appointment as per the requirement of the Vidyalaya.
- 5) Registration for walk-in interview: Only online registration will be accepted.
- 6) Last date for online registration is 20th March 2025 up to 3:00 PM.
- 7) Competency in teaching in English & Hindi is a must.
- 8) For all posts, recruitment rules of KVS will prevail. Educational Qualification and Remuneration as per KVS rules.
- 9) Candidates are required to bring all original certificates / Documents at the time of interview.
- 10) Eligible candidates have to report the Vidyalaya on time on the respective dates.
- 11) Engagement will be purely on Contractual Basis.
- 12) No TA/DA will be paid for attending the interview.


