- (5) Independent/Private Schools require to remit mandatory Annual Sports Fee of Rs.10,000/- (Rupees Ten thousand only) by way of online payment at the time of online Registration of Students/filling up of LOC (List of Candidates).
- (6) You must also comply with the other directions/conditions, if any given in your affiliation letter and send compliance to the Affiliation Unit, Delhi.
- (7) Your specific attention is invited on relevant points relating to admission, examination, session for admission, session for examination and provisions of Bye Laws for strict adherence. School will be liable for disaffiliation proceedings if found violating any of the norms given in the Affiliation letter.
