For admission under RTE -

- 1. Copy of online registration
- 2. Birth certificate issued by the competent authority
- 3. Certificate related to residence entered in the form, issued by the competent authority.
- 4. Caste certificate (in the name of the child) issued by the competent authority for the benefit of SC/ST.
- 5. OBC-NCL (OBC-NON CREAMY LAYER) certificate (in the name of the child) issued by the competent authority for the benefit of OBC quota.
- 6. EWS (Economically weaker section) certificate issued by the competent authority for the benefit of EWS quota.
- 7. Disability certificate issued by the competent authority for the benefit of Disability Quota (DA).
- 8. Service certificate and updated salary slip (for government employees)
- 9. Copy of child's Aadhar card
- 10. Self attested copy of distance of residence from school
- 11.Passport size photo of child
- 12.Postcard size photo of parents (family) with child

List of documents for admission under SERVICE CATEGORY:-

- 1. Copy of online registration
- 2. Birth certificate issued by the competent authority
- 3. Service certificate issued by the competent officer in which the name of the officer, name of the office and contact number of the office must be mentioned.

- 4. Recent month's salary slip.
- 5. Transfer certificate issued and signed by the competent authority and number of transfers in the last seven years. (Transfer is counted only when transferred by the competent authority, distance of at least 20km and minimum stay of six months).
- 6. Certificate (in the name of the child) issued by the competent authority for claiming SC/ST/OBC-NCL.
- 7. Residence certificate issued by the competent authority.
- 8. Copy of the child's Aadhaar card.
- 9. Passport size photograph of the child.
- 10. Postcard size photo of parent (family) with child.

NOTE:-

- (i) Mere Registration will not confer a right to admission.
- (ii) The minimum age for Registration/enrollment in Class-1 is six years as on 31st March 2025 and maximum age limit is 8 years.
- (iii) The Name, Gender, Date of Birth and Name of Parents of the Child should be same in all the documents (eg. Birth Certificate, Aadhaar Card, Caste Certificate etc.)
- (iv) Parents will ensure to submit all the documents on time for admission. All documents should be issued from appropriate offices by competent authority only.
- (v) Admission secured on the basis of any wrong / false certificate will get cancelled at any stage of verification and legal action may be forged against such cases.
