Sir,

Kindly refer to the D.O letter NO: 1150812/MOS (PP)/16 dated: 11-02-2016 issued by Sh.Ashok Kumar, Officer on Special Duty to MOS (Independent Charge), Ministry of Dev. of North Eastern Region, MOS, PMO, Ministry of Personnel, Public Grievances and Pensions, Deptt. of Atomic Energy & Deptt. of Space, Govt. of India (Copy enclosed for ready reference) where-under it was desired that the proposal for opening of Kendriya Vidyalaya at Jodhpur and Gandoh of Doda District under the Civil Sector be moved through Dy. Commissioner KV, Sangathan Regional Office. Chandigarh.

In this connection, a piece of state land measuring 64 Kanals (08 Acres) has been identified at Jodhpur (Doda) for the construction of Kendriya Vidyalaya. This land can be transferred to KVS for opening of new Kendriya Vidyalaya.

Further, a temporary accommodation belonging to the State Government (i.e. Community Facility Centre, Belna) has been identified and shall be made available to KVS free of rent till KVS constructs its own Vidyalaya building. The capacity of this building shall be augmented based on the requirement of KVS within the shortest possible time. Sufficient private accommodation for the staff is also available adjacent to the proposed site.

All other facilities which are pre requisite for opening of KV are available/ shall be made available in due course of time at the proposed location.

It is, as such, requested to kindly sanction and open KV at Jodhpur temporarily in the available CFC building and also issue orders for construction of KV building/other infrastructure on the identified land at the earliest.
