SPECIAL PROVISION:

1. Relaxation of B.Ed. qualification – In the absence of suitable candidates with B.Ed. Degrees in hard/very hard station and in remote areas of North – East and J & K, candidates with the following qualifications may be considered in different categories without B.Ed. qualification –

- (a) Post Graduate with 60 % marks in Science Subjects and 55 % in Humanities Subjects may be considered for the posts of PGTs, if suitable candidates with B.Ed. are not available.
- (b) Similarly in the case of TGTs, B.Sc. with 60% marks and BA with 55 % marks may be considered for appointment on part time contractual basis if suitable candidates with B.Ed. are not available.
- (c) Graduates may be considered for the post of Primary Teachers if candidates with Senior Secondary/Plus 2 / Inter with J.B.T. qualification are not available.
- **2. Relaxation in CTET** In the absence of CTET qualified candidates, candidate without CTET qualification may be considered if otherwise eligible as per KVS recruitment rules.

TERMS & CONDITIONS

- 1. Candidate should bring self-attested Xerox copies of all documents with originals for verification along with the application form duly filled up in all respects on the day of interview.
- 2. In case of Non- availability of B. Ed candidate preference will be given to Non- B. Ed candidates.
- 3. Merely appearing in the written examination for the post of PRT (if conducted) will not be deemed as a right to appear for the interview.
- 4. Candidates will be eligible for appearing in the interview only after the verification of documents.
- 5. A candidate applying for various posts must fill separate forms and attach separate documents as per the number of post(s) applied for and will appear separately in the interview for the said post(s) as per the date and time mentioned in the advertisement.
- 6. No TA/DA for attending test/interview will be paid. Appearing in the test/interview merely will not have any right of either part time or permanent employment in the KVS.
- 7. Candidates must report at 08.00 am on the day of interview along with dully filled application forms with two sets of self attested photocopies of all documents and original for verification. No TA/DA for attending the test/interview,
- 8. Remuneration as per KVS norms.
