With reference to your letter on the subject cited above, I am directed to say that the Governor of Assam is pleased to order for allotment of sarkari land measuring 2.8 Hectore or 15(fifteen) Bigha covered by Dag No. 899(Ka) and(Kha) of village Baladmari Pt. I under Balijana Circle in favour of Kendriya Vidyalaya, Goalpara for the purpose of establishment of the KV. School subject to utilization for the specific purpose within 3(three) years, failing which, the land so allotted will automatically stand cancelled and reverted to Government in Revenue Department.

The land records may be corrected accordingly after handing over possession of the land to the concerned authority.

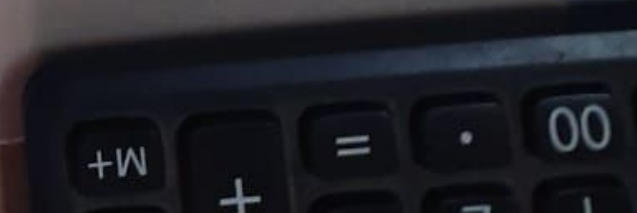
