For the Academic Session 2026-27, the panels for the various possible vacancies on contract basis (Part-Time) are to be made through the Interview on 19.02.2026 and 20.02.2026. Panels for the teaching posts (possible vacancies which may arise due to leave or any other reason), Coaches (Dance and Sports), Computer Instructor, Nurse, Special Educator (PRT), Vocational Trainer and Counsellor are to be made. In this light, it is made clear that arrangements have been made for the online registration starting from 09.02.2026 till 16.02.2026 (12:00 Midnight) for the said interview. Important Instructions:-

- 1) Registration will remain open from 09.02.2026 to 16.02.2026 till Midnight. No registration will be entertained after 16.02.2026.
- 2) Interview will be started at 9:00 AM for the registered and eligible candidates.
- 3) Candidates should bring original and one set of self-attested copies of certificates, testimonials, photo identity and one passport size photo. Candidates will have to ensure the collection of their original documents just after the documents verification before leaving the desk of verification.
- 4) Proof of identity (POI) and other requisite documents along with passport size photographs must be carried out on the day of walk in interview.
- 5) A self-attested copy of Proof of identity (POI) will be submitted along with each set of documents for the post or different posts, as the case may be.
- 6) Kindly check your eligibility before applying. Bilingual proficiency (Hindi and English) is required for all the posts.
- 7) Only online registration by the candidate within the permissible time limit shall be considered. No other form of registration shall be considered.
- 8) The following documents need to be submitted to the Document Verification Team:
 - i. Duly filled bio-data.
 - ii. Self-attested photocopies of eligibility documents.
 - iii. Self-attested photocopies of identity proof and address proof.
 - iv. A self-attested document containing your mobile number and email ID for communication.
 - v. Self-attested photocopies of documents claiming experience in the post held for the post.
 - vi. One passport size colour photograph for each post applied for.
- 9) Age Limit for all above posts: Minimum and maximum age limit shall be 18 and 65 years respectively as on 31st March, 2026.
- 10) No TA/DA will be paid for attending the interview. Terms and conditions are as per KVS norms. Knowledge of Computer is desirable for all posts.
- 11) This interview is only for preparing a panel of different posts to be engaged on purely part time contractual basis as and when required.
- 12) Complete details should be filled carefully in the Bio-Data form. Paste a recent photograph and signature at the appropriate places as per instructions contained in the Bio-Data form.
- 13) Candidates are required to have a valid personal Email ID and Mobile number. Both Email id and Mobile should be kept active during the currency of this contractual appointment. In case a candidate does not have a valid personal Email ID, he/she should create his/ her new Email ID before applying.
- 14) At the time of filling the Bio-Data form, candidates are advised to fill their particular i.e. Name, Father's/ Mother's Name, Date of Birth, Gender and other

- details correctly. After registration or at the time of interview, the request for change of particulars in the bio-data form will not be entertained by this KV.
- 15) Candidates are required to visit KV website: <https://tatanagar.kvs.ac.in/> regularly with regard to view the updates regarding Interview.
 - 16) Neither Information shall be entertained by this KV nor shall send a separate intimation to the candidates to this effect.
 - 17) No fee is required to be paid by candidates for registration or interview.
 - 18) A candidate may apply for more than one post if he /she is eligible and desires to do so. In such cases, the candidate will have to fill the Registration-cum-Bio Data Form separately for all the posts applied for. A set of self-attested photocopies of all Certificates, Mark-sheets, Testimonials and id proof must be attached with each Registration-cum-Bio Data Form.
 - 19) Candidates must carry the valid id proof on the day of Interview. ID proof includes PAN CARD /AADHAR CARD /PASSPORT /DRIVING LICENCE /VOTER ID CARD / ANY VALID PHOTO ID ISSUED BY GOVT.
 - 20) After registration within the permissible time limit, Candidates may have to wait for their turn for attending the Interview depending on the number of Candidates.
 - 21) Legal action may be taken for the falsification of the information.
 - 22) After the due process of the interview, the panels of different posts will be prepared and uploaded on the website of the Vidyalaya. In lieu of need assessment of the Vidyalaya, listed candidates in the panel will be called upon as per rank assigned. In case of non-response or failure to report, the next in merit candidate will be called upon in the interest of the students. Services of the selected candidate in ranks panel will be taken if it is found satisfactory after the class observation by the Principal/Vice Principal/Senior Most Teacher.
 - 23) For contractual teachers/coaches etc., salary/honorarium will be payable as per the KVS rules applicable from time to time.
 - 24) In the interest of the Vidyalaya, the Principal has the right to remove any contractual employee of the Vidyalaya without assigning any reason.
 - 25) Knowledge of computer is desirable for all posts.
 - 26) Before availing the services of the selected candidate, a letter of consent for the benefit of KVS will be signed between the candidate and the Principal on non-judicial stamp paper of minimum 100.
 - 27) KVS Recruitment Rules along with terms and conditions will apply. Only for simplicity and detailed description, the following Recruitment Rules for contractual appointment have been uploaded on the website of PM SHRI Kendriya Vidyalaya Tatanagar .
 - 28) If insufficient applications are received for any post then re-interview may be conducted or eligible and qualified contract teachers may also be selected from the panel of other KVs of Ranchi Region.

ELIGIBILITY CRITERIA – POST GRADUATE TEACHER (PGT)

PGT - English, Hindi, Maths, Physics, Chemistry, Biology, Commerce, Economics

Essential Qualification:

- (1) Two years' Integrated Post Graduate M.Sc. Course of Regional College of Education of NCERT in the concerned subject; Or Master Degree from a recognized University with atleast 50% marks in aggregate in the following subjects:
 - a) PGT(English) - English
 - b) PGT(Hindi) – Hindi or Sanskrit with Hindi as one of the subjects at Graduate level.
 - c) PGT(Maths) - Mathematics/ Applied Mathematics
 - d) PGT(Physics)–Physics/Electronics/Applied Physics/Nuclear Physics
 - e) PGT(Chemistry) - Chemistry/ Biochemistry.
 - f) PGT(Commerce) – Master's Degree in Commerce. However, holder of Degrees of M.Com in Applied/ Business Economics shall not be eligible.
 - g) PGT (Economics) – Economics/ Applied Economics/ Business Economics.
 - (2) B.Ed. or equivalent degree from recognized University.
 - (3) Proficiency to teach through Hindi & English medium.
- Desirable: Knowledge of working on Computer.

PGT (Computer Science)

ESSENTIAL QUALIFICATIONS:

1. M.Sc. (Computer Science/IT) / MCA from a recognized institution/University with at least 50% marks.

OR

M.E. or M. Tech. (Computer Science/IT) from recognized institution/University with at least 50% marks.
2. B.Ed. Degree from NCTE recognized Institution/University with at least 50% marks

OR

Three years integrated B.Ed.-M.Ed. from NCTE recognized Institution/University with at least 50% marks

OR

Four years integrated degree with at least 50% marks from NCTE recognized institution/University including B.Ed. component.

ELIGIBILITY CRITERIA – TRAINED GRADUATE TEACHER (TGT) TGT – Sanskrit, Hindi, English, Social Science, Maths, Science

Essential Qualification:

- (1) Four years' Integrated degree course of Regional College of Education of NCERT in the concerned subject with at least 50% marks in aggregate;

OR

Bachelor's Degree with at least 50% marks in the concerned subjects/ combination of subjects and in aggregate. The electives subjects and Languages in the combination of subjects as under :
- a) For TGT(Sanskrit): Sanskrit as a subject in all the three years.
- b) For TGT(Hindi): Hindi as a subject in all the three years.
- c) For TGT(English): English as a subject in all the three years.
- d) For TGT(S.Sc.): Any two of the following- History, Geography, Economics and Pol. Science of which one must be either History or Geography.
- e) For TGT(Maths): Bachelor Degree in Maths with any two of the following subjects: Physics, Chemistry, Electronics, Computer Science, Statistics.

- f) For TGT(Science): Botany, Zoology and Chemistry.
- (2) B.Ed. or equivalent degree from recognized University.
- (3) Pass in the Central Teacher Eligibility Test (CTET) (VI-VIII) conducted by the CBSE in accordance with the Guidelines framed by the NCTE for the purpose.
- (4) Proficiency to teach through Hindi & English medium.

Desirable: Knowledge of Computer Applications.

ELIGIBILITY CRITERIA Special Educator (TGT)

Essential Qualification:

1. Graduation Degree from a recognized institution/University with minimum 50% Marks
2. Any of the following from recognized institution/University: B. Ed. (Special Education) with atleast 50% marks;
OR
B. Ed. (General) with atleast 50% marks alongwith one year Diploma in Special Education;
OR
B. Ed. (General) with atleast 50% marks alongwith two years Diploma in Special Education;
OR
B. Ed. (General) with atleast 50% marks alongwith Post Graduate Professional Diploma in Special Education (PGPD);
OR
B. Ed. Special Education with atleast 50% marks and Post graduate professional Certificate in Special Education (PGPC);
OR
PG Diploma in Special Education (Mental Retardation);
OR
PG Diploma in Special Education (Multiple Disability: Physical and Neurological);
OR
PG Diploma in Special Education (Locomotor impairment and Cerebral Palsy);
OR
Secondary Level Teacher Training Course in Visual Impairment;
OR
Senior Diploma in Teaching the Deaf; OR B.A.B. Ed. with atleast 50% marks in Visual Impairment.
OR
Any other equivalent qualification approved by RCI
3. Qualified in Central Teacher Eligibility Test (CTET) (Paper - II) conducted by Central Board of Secondary Education (CBSE). Relaxation up to 5 percent in the qualifying marks shall be allowed to the candidates belonging to reserved categories such as SC/ST/OBC-NCL/PwBD in CTET.
4. Registration with Rehabilitation Council of India (RCI) with valid CRR number.
5. Proficiency to teach in Hindi and English.

Note: B.A. B.Ed. in Visual Impairment being integrated course of graduation and B.Ed. Special Education, separate graduation is not required in the case of candidate possessing this degree.

Desirable: Knowledge of Computer Applications

ELIGIBILITY CRITERIA – PRIMARY TEACHER (PRT) PRT

Essential Qualifications:

- (1) Senior Secondary (or its equivalent) with at least 50% marks and 2-year Diploma in Elementary Education (by whatever name known)

Or

Senior Secondary (or its equivalent) with at least 50% marks and 4-year Bachelor of Elementary Education (B.El.Ed.)

Or

Senior Secondary (or its equivalent) with at least 50% marks and 2-year Diploma in Education (Special Education)

(2) Pass in the Central Teacher Eligibility Test (CTET) (I-V) conducted by the CBSE in accordance with the Guidelines framed by the NCTE for the purpose.

(3) Proficiency to teach through Hindi & English medium.

Desirable: Knowledge of working on Computer.

ELIGIBILITY CRITERIA – COMPUTER INSTRUCTORS (PRIMARY & SECONDARY)

Essential Qualifications:

At-least 50 % marks in aggregate in any of the following: B.E or B. Tech. (Computer Science/IT)/ BCA/ MCA/ M.Sc.(Computer Science)/ M.Sc.(Electronics with Computer Science component)/ M.Sc.(IT)/ B.Sc. (Computer Science) from a recognized University.

OR

Bachelor's/ Master degree in any Science subject/ Mathematics from recognized University with Post Graduate Diploma in Computer Application from government recognized University/ institute.

OR

Post Graduate degree in any subject with Post Graduate Diploma in Computer Application from government recognized University/ Institute / 'A' Level from 'DOEACC'.

Proficiency in teaching in Hindi and English media.

Desirable: Preference will be given to the candidate suitable to teach AI.

ELIGIBILITY CRITERIA – SPORTS COACH

Sports Coach in Kabaddi / Kho-Kho / Volley Ball / Taekwondo / Cricket / Football / Basketball

(1) Diploma / Degree / Graduation in Concerned Field. Specialisation if any. Represented in any at State / National Level.

(2) Proficiency in Hindi and English.

ELIGIBILITY CRITERIA – DANCE COACH

Dance Coach

Degree or, diploma from recognised Institute / University and Professional Competency in concerned field.

ELIGIBILITY CRITERIA – NURSE

Nurse

Degree/ Diploma in Nursing from recognized Institute/ University with valid registration. Preferable having attended workshop/course or having certificate of Life Saving training in emergent situations

ELIGIBILITY CRITERIA - COUNSELLOR

Counsellor

Essential: B.A./B.Sc.(Psychology) with Certificate of Diploma in Counselling from a recognized College or University.

Desirable: Minimum of one year Experience in providing career educational counselling to students at schools.

OR
Working knowledge and experience in Placement Bureaus.
OR
Registration with rehabilitation council of India as Vocational Counsellor.

ELIGIBILITY CRITERIA – SPECIAL EDUCATOR (PRIMARY TEACHER)

ESSENTIAL QUALIFICATION:

1. XII Passed with minimum 50% marks in aggregate
2. Any of the following from recognized university/Institute: Two-year D.Ed. Special Education in any of the category of disability.

OR
One year Diploma in Special Education (DSE) in any of the category of disability.

OR
Diploma in Community Based Rehabilitation (DCBR) with 6 months Certificate course in Education of Children with Special Needs.

OR
Post Graduate Diploma in Community Based Rehabilitation (PGDCBR) with 6 months Certificate course in Education of Children with Special Needs.

OR
Diploma in Multi Rehabilitation Worker (MRW) with 6 months Certificate Course in Education of Children with Special Needs.

OR
Junior Diploma in Teaching the Deaf

OR
Primary level Teacher Training course in Visual Impairment.

OR
Diploma in Vocational Rehabilitation-Mental Retardation (DVR-MR)/Diploma in Vocational Training and Employment- Mental Retardation (DVTE-MR) with 6 months Certificate course in Education of Children with Special Needs.

OR
Diploma in Hearing Language and Speech (DHLS) with 6 months Certificate course in Education of Children with Special Needs.

OR
XII passed with any RCI recognized qualification of minimum one year duration and 6 months Certificate course in Education of Children with Special Needs.

OR
Any other equivalent qualification approved by RCI

3. Qualified in Central Teacher Eligibility Test (CTET) (Paper – 1) conducted by Central Board of Secondary Education (CBSE). Relaxation up to 5% in the qualifying marks shall be allowed to the candidates belonging to reserved categories such as SC/ST/OBC/PwBD in CTET.

4. Registration with Rehabilitation Council of India (RCI) and having valid CRR number.

5. Proficiency to teach in Hindi and English

Desirable: Knowledge of Computer Applications

Eligibility Criteria: Vocational Trainer

- B.E.,B.Tech/M.Tech(Electronic & Communication Engineering).
- Minimum 01 year experience.
- Rs. 25,000/- per month to be given to vocational trainer
