As communicated by the Ministry of Education in the letter dated September 2, 2024, it is to inform you about the implementation of Automated Permanent Academic Account Registry (APAAR) IDs for students in Kendriya Vidyalayas (KVs).

APAAR is a ground breaking identification system introduced under the 'One Nation, One Student ID' initiative by the Government of India, in alignment with the National Education Policy (NEP) 2020. This system assigns each student a unique 12-digit code, which will digitally manage and store their comprehensive academic profile, including scorecards, mark sheets, grade sheets, degrees, diplomas, certificates, and co-curricular achievements.

The APAAR ID functions as a lifelong, unique digital identifier, facilitating a streamlined and secure management of a student's academic journey. The system offers significant benefits, such as:

- **Unified Tracking:** Efficient monitoring of student progress.
- **Digital Integration:** Seamless connection with educational platforms.
- **Seamless Transitions:** Easy transfer of academic records.
- **Visualization of Learning Pathway:** Analysis of educational interventions and outcomes at all administrative levels through VSK.

To implement this initiative, please ensure that all schools in your region take the following actions:


1. **Parent-Teacher Meeting (PTM):** Schedule a special PTM for classes 9 to 12 by September 13, 2024, to inform parents about APAAR IDs and their benefits. A step-by-step guide for conducting the PTM is attached for your reference.
2. **APAAR ID Creation:** Adhere to the APAAR ID creation process outlined in the attached document, "APAAR ID Creation Process - Flow through the UDISE+ Portal."
3. **Review FAQs:** Ensure that stakeholders are familiar with the attached Frequently Asked Questions (FAQs) document regarding APAAR.
4. **Parental Consent:** Obtain consent from parents using the attached Annexure I.
