In recent years we have seen several developments in our education system and it took drastic change after implementation of National Education Policy 2020. Will the Minister of Education be pleased to state.

<u>Minister of Education</u> (Ms. Khushi Yadav): Honourable Speaker Madam respected member is right.

(a): Education plays an important role in the development of an enlightened, socially conscious, knowledgeable & skilled nation that can find & implement robust solutions to its own problems.

Considering the importance of education. A number of transformative changes have taken place both in school and higher education after Announcement of **NEP 2020.**

In School Education, changes include introduction of early childhood care and education; emphasis Foundational Literacy and Numeracy(**FLN**); National Curriculum Framework for all levels, extensive use of technology to enable multi-mode access To Education; Digital Infrastructure for Knowledge Sharing (**DIKSHA**); Teacher Education Programme in Multi-disciplinary environment; Performance Assessment, Review, and Analysis of Knowledge for Holistic Development; National Digital Education Architecture (NDEAR) for Creating a unifying national digital infrastructure; "New India Literacy Programme or ULLAS"

Targeting all non-literates aged 15 years and above. NEP 2020 recommends for regular formative assessments to foster a deeper understanding of Subjects and skills among students, moving away from rote learning and exam-centric Preparation.

(b): The Department of School Education and Literacy is implementing the initiative of Vocationalisation of School Education under Centrally Sponsored Scheme 'Samagra Shiksha'. The scheme aims at integrating Vocational Education with general academic education in all Secondary/Senior Secondary schools; enhancing the Employability and Entrepreneurial abilities Of the students, providing exposure to work environment; and generating awareness amongst Students about various career options so as to enable them to make a choice in accordance with Their aptitude, competence and aspirations.

Railway Minister (Ms. Tripti):माननीय अध्यक्ष महोदया, मैं आपके माध्यम से सदस्य को सूचित करना चाहती हूँ कि,

(a) & (b): पिछले कुछ वर्षों में किए गए विभिन्न सुरक्षा उपायों के परिणाम स्वरूप, पटरी से उतरने सिहत परिणामी रेलदुर्घटनाओं की संख्या में भारी कमी आई है।हाल के आंकड़ों से पता चलता है कि परिणामी रेल दुर्घटनाएँ 2000-2001 में 473 से घटकर 2023-24 में 40 हो गई हैं। 2023-24 के आंकड़ों में जून 2023 में हुई कोरोमंडल एक्सप्रेस ट्रेन दुर्घटना भी शामिल है। जहाँ तक दुर्घटनाओं और मुआवज़े के बारे में प्रश्न है। कंचनजंगा एक्सप्रेस ट्रेन दुर्घटना और चंडीगढ़-डिब्रूगढ़ एक्सप्रेस ट्रेन दुर्घटना क्रमशः 17.06.2024 और 18.07.2024 को हुई, जिसमें 12 यात्रियों की जान चली गई और 57 घायल हो गए।हमारी सरकार ने मृतक के परिवार और प्रत्येक पीड़ित परिवार को आवश्यक सहायता प्रदान की है। यह राशि लगभग 25 करोड़ रुपये है।

(a) To (c): The Government of India attaches high degree of importance to the prevention and countering of the crime of human trafficking, especially women and children. Section 143 of the Bharatiya Nyaya Sanhita (BNS), 2023 provides penal provisions for strict punishment for any offence of human trafficking. Most of these complaints relate to delay or non-payment of wages as well as non-payment of termination benefits, unauthorized retention of passports, excessive working hours, non-provision of leaves, non-payment of overtime wages, providing work different from that promised at the time of recruitment, ill-treatment/harassment, non-issuance/renewal of residence permit, non-cancellation of visa, refusal to grant exit/re-entry permit to visit India, non-permission to return to India on final exit visa after completion of contract, non-provision of medical and insurance facilities, non-payment of compensation on death, etc.

The answer to the second part of the question asked by the Hon'ble Member is that The Government has set up various channels to enable Indian workers abroad to reach out to Missions/Posts in case they require any assistance.

- (1) Workers can contact Missions/Posts through walk-in interviews, email,
- (2) Multilingual 24x7 emergency numbers, grievance redressal portals such as MADAD, CPGRAMS and e-Migrate, social media etc.
- (3) Pravasi Bharatiya Sahayata Kendras (PBSK) has been established in New Delhi and Dubai (UAE), Riyadh and Jeddah (Saudi Arabia) and Kuala Lumpur (Malaysia) to provide assistance.
- (4) Providing guidance and counseling to Indian workers in distress. Missions/Posts in Gulf countries also have dedicated labour branches that ensure prompt redressal of labour grievances.

(13)PASSING OF THE BILL

SPEAKER (ARYA): Minister of State for Personnel, Public and Pensions Please proceed

Minister of Personnel, Public grievances and Pensions (Ms. Ruchi):

Thank you Honorable Speaker Madam......

Today's topic is about preventing unfair means in the public examinations, we can say with evidence that in the last ten years, various provisions have been made for the youth, especially in the matter of recruitment of youth in government jobs or selection in higher education institutions. In all these processes, it has been seen that what kind of transparency should be there and how every youth can get adequate opportunity to use his talent, ability and hard work.

Sir, our government ensured that Exams should be conducted in a time bound manner. For a time, the examination process of Staff Selection Commission used to last for about two years. Its duration has now been reduced to sixty-eight or nine months and efforts are on to reduce it further so that every youth gets timely opportunity to try his luck.

In recent years we have seen many recruitment scams like:

In December, 2022, fraud is found in the teacher recruitment exam.

In few states, scam was found in Sub-Inspector Recruitment exams.

Similarly, In May, 2022, fraud takes place in the several other Recruitment Exams.

In the Combined Graduate Level of the Staff Selection Commission in 2017, there are many examples of this and there are many more.

But, without going into that detail, I will say that who has to bear the brunt of this? Many capable children who go to give the exam after preparing hard, who prepare with parents hard earned money, are left without a fair chance.

Just few days back you must have read in the newspapers that a girl from Kota committed suicide. That girl leaves behind a note in her suicide note, "Mummy, papa, please forgive me. I cannot do it. I am the worst daughter."

The whole of India cried after reading this suicide note. Therefore, through you Madam I may appeal to the House that our children, your children, should be saved

from such a situation. I don't think anyone will refuse this. Therefore, with this feeling this bill is being brought. Thank you

Speaker (ARYA): Leader of Opposition

<u>Leader of Opposition:(Mr. Aditya)</u>: Madam, I rise to dwell on the legislative document under the nomenclature, the Public Examinations (Prevention of Unfair Means) Bill, 2024. It may be called as Anti Cheating Bill.

The first thing is that through this legislative document, minister is talking about bringing transparency. But according to the Transparency International Report, India's ranking on the Corruption Perception Index dropped from 85 in 2022 to 93rdin 2023.

(SHAME......SHAME....) by opposition party leaders

That means, the Corruption Perception Index has been alarming by increasing. Here, in this Bill, certainly, lofty ideals have been enshrined but the issue is that you are putting your entire emphasis on punishment.

Why are preventive Measures not being conceived? The Bill has penal provisions for committed Offences but lacks preventive measures to reduce such acts. ... (Interruptions)

Therefore, in my opinion, government should emphasize towards more stringent security systems that will prevent such offences rather than making penal laws.

Speaker (Arya): Minister of Personnel, Public and Pensions.....

Kindly clarify the doubts raised by Leader of opposition.

Minister of Personnel, Public Grievances and Pensions (Ruchi): Honorable Speaker madam, though I am not a law knowing person, to my Limited knowledge punishment itself is a deterrent for prevention. This is a first step towards prevention. And then, as we move on from this experience, we will collectively apply our minds and go in for further steps also. But if we do not take even this first step, and then we will not be preventing anything at all.

Speaker (ARYA): YES, MEMBER FROM OPPOSTION PARTY

OPPOSTION MEMBER (Mr.Brijesh Kumar Kushwaha): Thank you, honorable speaker madam, for giving me this opportunity to speak on this Bill.

Madam, the Public Examinations (Prevention of Unfair Means) Bill, 2024, which is moved by the Minister of State in the Ministry of Personnel, Public Grievances and Pensions seeks to identify the following unfair means and Offences during public examinations:-

- (i) Question paper or answer key leaks;
- (ii) Participation in collusion with others to effect question paper or answer key Leaks; and
- (iii) Accessing or taking possession of question paper or an Optical Mark Recognition (OMR) response sheet without authority. Any examination conducted by the Union Public Service Commission (UPSC), Staff Selection Commission. The young people of our country need justice as far as every competitive examination are concerned. Unfortunately, there are so many incidents

before us where they face injustice. This law will make sure that in future, these types of incidents do not happen, and it will be Helpful for lakhs and lakhs of young people of our country. With these words, I support this Bill. Thank you.

Speaker (ARYA): Treasury Bench member (Ms. Shahin Afreen)

Ms. Shahin Afreen:

Page 5, line 13,-after "punished"

Insert "with imprisonment for a term not less than three Years but which may extend up to ten years and". Page 5, omit lines 28 to 31. SPEAKER (Arya): Now the House will take up Private Members Resolution,

Mr. Utkarsh Sah to move the Resolution.

Mr. Utkarsh: Honorable Speaker Madam, I move the following resolution.

This house recommends that the government should bring in the **Prevention of Torture Act**, as a full-fledged legislation to prevent the inhumane treatment met out to detainees and prisoners. As we all know that India is a signatory to "THE CONVENTION AGAINST TORTURE AND OTHER CRUEL, INHUMAN & DEGRADING TREATMENT OR PUNISHMENT" as adopted by UNITED NATIONS GENERAL ASSEMBLY on 19th of December 1975 and India signed the same on 14th of October 1997.

Speaker (Arya); Member Yes.....: (Ms. Priti Jha):

Honorable Speaker (Arya): Honorable Home Minister pleases......

Home Minister (Ms. Saumya Kriti):

Madam, I extend my sincere thanks to (Mr. Utkarsh) for bringing to the notice of the house this very serious issue of **Prevention of Torture in Indian Jails** which has become a national shame for our country.

For our government human rights protection is foremost priority we believe that Denial of People Human Rights is To Challenge Their Very Humanity and so our government has tried to make a difference time and again by amending the acts which control the administration of Prison functions.

Our government since past many years has been successfully running the selfemployment scheme of in various prisons for several years and it makes me proud to announce that nationwide revenue of 36 crores has been generated through these schemes. It is also noteworthy that that International Committee of Red Cross in its annual report of Jail visits has enlisted Indian Prisons as one of the most habitable and up-to-date Prisons among developed nations.
