IV. DAY 4: THURSDAY – July 25, 2024 (Annexure- 4)

Cultural Day- Special cultural day to be organised for inculcating a sense of unity and diversity among students.

VII. DAY 7: SUNDAY – July 28, 2024 (Annexure- 7)

Community Involvement Day- Fostering collaboration with local communities, SMCs, NTA/PTA, PRIs for encouraging socio-emotional well-being of students and providing an ecosystem for skill development. [Celebrating birthdays/special occasions (Tithi Bhojan) involving the community as a whole.

With a view to extend support for Shiksha Saptah activities among school children, the Department of School Education & Literacy has prepared Concept notes and a list of suggestive daily activities which is annexed with this letter.

In addition, two days activities may be organised at Block/ District level in the corresponding DIETs and one day may be celebrated at the State level by the SCERT during the Shiksha Saptah to make it more inclusive and expansive.

The State Project Director may be appointed as the nodal officer. The nodal officer will be the single point of contact to facilitate schools in this programme. The nodal officer may create a tracker for their State/UT for collection of data and to upload the same including photographs of events.

You are requested to work on spreading awareness among all schools so that school children and other stakeholders know about Shiksha Saptah Celebration and also circulate enclosed concept notes with or without customisation, to familiarise them with the salient features of NEP 2020 in their daily activities.
