1.	Administrative Building	It appears from visual observation and Non-Destructive Tests of Concrete, the Building (as on date) appears to be satisfactory.
2.	Community Centre	It appears from visual observation and Non-Destructive Tests of Concrete, the Building (as on date) appears to be satisfactory but in community Centre deep cracks have been observed in between plinth protection and building wall joints in the sides and back portion. Need to be repaired immediately.
3.	Kendriya Vidyalaya Building and Canopy	It appears from visual observation and Non-Destructive Tests of Concrete, the Building and Canopy (as on date) appears to be satisfactory.
4.	Quarter No. D 18/2 and D 18/4	It appears from visual observation and Non-Destructive Tests of Concrete, the Building (as on date) appears to be satisfactory but front Balcony Area Column & Beam have been observed major cracks. Need to be repaired immediately.
