Subject: Implementation of RTE Act 2009.

Madam/Sir,

You are aware that the RTE Act 2009 has been implemented in KVS w.e.f. the year 2010-11. Though the KVs are making their all out efforts to realize the goals of the constitutional provision, many cases of complaint have come to our notice from parents, NGOs and NCPCR.

2. To avoid this situation, it is required that all the stakeholders are adequately sensitized towards the various provisions relevant to KVs. You are, therefore, requested to direct the Principals of your region to convene a special meeting of VMC to apprise them with various proviso of the Act which may include, inter alia:-

- The RTE Act 2009 is applicable to Kendriya Vidyalayas under specified category 2(n)(iii) and (p).
- As per Chapter IV 12(I) – The KVs shall admit in Class I to the extent of atleast 25% of the strength of that class children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion.
No fee to be charged from the children admitted under 25% of the quota.
It has been decided that one set of NCERT text books for his/her class to each child will be provided by the school and other expenses on account of note books, stationary, uniform and transport will be reimbursed by the parent on production of proper bills in respect of 25% of the children admitted under the Act as per the provision specified by MHRD.
- 1. No screening test to be conducted from Class I to VIII for admission.

- For admission in Class I under RTE provisions selection process should be random (draw of lot).
 - The children suffering from disability will also be covered under RTE Act
 - No children to be detained in any class up to 8th standard.
 - The transfer certificate may not be insisted for admission up to Class VIII.
 - Admission to be granted for the children under RTE Act as per admission guidelines.
 - The protection of Right of children to be ensured as per the Act.
 - The Right to Education Protection Authority (RIEPA) has been constituted at National and State level to monitor the protection of child rights.
 - Every school is advised to form a committee to protect the child rights at Vidyalaya level.
 - No corporal punishment is to be imposed on any child.
 - Adequate training to be provided for the teachers on the act.
 - The Directors, ZIETs are requested to ensure the inclusion of modules on RTE Act during In-service course programmes.
 - The parent advocacy programme on RTE act may be taken up in every school.
 - The Chairman, VMC of every school may be requested to convene a special meeting at school level to sensitize all the stakeholders on RTE Act.
3. Besides, all possibilities should be explored at individual or organization level to extend a helping hand to every child so that no hindrance comes in his/her way in getting education.
4. It is a collective responsibility of the educators, officers, principals, teachers, parents' management and children to implement the RTE Act in letter and spirit.
5. You are requested to disseminate the above instructions to Chairman, VMCs also under your jurisdiction separately.
