Subject: Minutes of the Virtual review meeting held with Kendriya Vidyalaya Sangathan under the Chairpersonship of Economic Advisor, DoSEL on 01st December, 2023

A virtual meeting was held under the Chairpersonship of Economic Advisor, D/o SE&L on 01st December, 2023 with the Nodal Officer of Vidyanjali & Regional Officers of KVS to review the progress of Vidyanjali.

2. At the outset, the Economic Advisor (D/o SE&L) welcomed all the participants and briefed about the Vidyanjali programme. After that, presentation on "User Guide for Volunteer Registration & contribution Process on Vidyanjali portal" & "How to raise Request on Vidyanjali Portal" were presented by Consultant, Vidyanjali.

3. During the meeting, following action points/suggestions/feedbacks were brought forward:

- i. Although almost all Kendriya Vidyalayas have been onboarded on the portal, with only a very few remaining, all regions were urged to complete the onboarding process and to ensure that schools under their jurisdiction submit requests on the portal as required. Further, the regions were also encouraged to reach out to respective alumni and encourage them to contribute to these schools through the Vidyanjali portal.
- ii. A Vidyanjali banner or standee may also be prominently displayed at the entrance of the campus to promote the initiative.
- iii. Furthermore, all regional offices of KVS were urged to regularly share information about Vidyanjali on their respective social media platforms to amplify the visibility of the program.

- iv. Based on the demands for the region wise orientation session, Nodal Officer of Vidyanjali in KVS was requested to design and share the schedule for conducting orientation session with the principal of KVs in consultation with PMU, Vidyanjali.
4. Thereafter, the floor was opened for the discussion. All the region wise queries were answered during the meeting. The meeting ended with a vote of thanks to all the members by the Chairperson.
